Press Release: CBS presents Foreign Trade Statistics for the second quarter of 2015

In the infographic frame number 1 reflects that for the second quarter of 2015 import to the free circulation area of Aruba increased with $0.1 \%$ compared to the same quarter of the previous year. The value for this quarter to this area was Afl. 473 mln .

In the infographic frame number 2 represent import of "Food" products which increased from Afl. 114 to 118 mln . The increase is observed in the segments 'Edible vegetables, prepared or preserved' (Afl. 11 to 12 mln .), 'Fish, crustaceans and other invertebrates, prepared or preserved' (Afl. 8 to 9 mln .) and 'Poultry and edible poultry offal, prepared or preserved' (Afl. 6 to 7 mln .). "Non-food" Products decreased from Afl. 359 to 356 mln . These decreases is seen again as the previous quarter for the segments "Fuels \& lubricants" while "Other non-food', Boilers, machinery, mechanical appliances and parts thereof' and 'Textiles, textiles articles, clothing and accessories' increased around 1.4\%.

In the infographic frame number 3, import to 'some big companies' decreased from Afl. 64 to 51 mln and is directly related to the import of 'gasoline' which decreased from Afl. 26 to 17 mln . This is due to a reduction in the price of the product regardless of increase the volume. 'Import to other' increased from Afl. 409 to 423 mln . This increase is related to the import of 'Other garments, knitted, crocheted, of man-made fibers' (Afl. 0.2 to 3 mln ) and 'Motor cars and other motor vehicles principally designed for passenger with a CIF value to Afl. 20.000' (Afl. 4 to 7 mln ).

In the infographic frame number 4 represents an analysis of the most important import countries by term of delivery (shipment) when shipping their products to Aruba. F.O.B.(Freight on board) is primarily used namely $71 \%$ and $22 \%$ uses C.I.F. (Cost insurance and freight).
