

Consumer Price Index, base period December 2006 October 2016

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of October 2016.

The CPI for October 2016 is 117.61, an increase of 0.2% compared to the index of September 2016 (117.35) and accumulating a decrease of 0.7% for the year 2016 up to and including October.

The percentage change of the CPI over the last twelve (12) months (October 2015 to October 2016) is -0.1%, an increase of 0.7 percentage point (ppt) compared to the percentage change for the same period of last year (-0.8%).

The period average percentage change of the CPI for the period October 2015 - October 2016 is -1.0%, a decrease of 1.9 ppts compared to the period average percentage change over the period October 2014 - October 2015 (0.9%).

During this month, seven (7) of the twelve (12) sectors registered increases in prices. The increases which had the greatest influence on the CPI were registered for the "Food and non-alcoholic beverages" (1.9%), "Household operation" (0.4%), "Recreation and culture" (0.2%) and "Housing" (0.1%) sectors, causing an effect of 0.27, 0.02, 0.02 and 0.02 ppts, respectively. The increases in the remaining sectors had an effect of 0.01 ppt on the CPI of October 2016.

Aforementioned increases were partially offset mainly by decreases in the indices for the "Transport" (-0.3%) and "Communications" (-0.7%) sectors, which had an influence of -0.06 and -0.04 ppts on the CPI of October 2016, respectively. The decreases in the remaining sectors had an effect of -0.01 ppt on the CPI of October 2016.

The increase in the "Food and non-alcoholic beverages" sector was mainly caused by an increase of 2.2% in the category "Food", which contributed to an effect of 0.27 ppts. The increase in the "Household operation" sector was mainly due to an increase in the category "Household textiles" (3.4%), which contributed to an effect of 0.02 ppts. The increase in the "Recreation and culture" sector was mainly due to an increase in the category "Holidays" (8.6%), which contributed to an effect of 0.05 ppts. The increase in the "Housing" sector was due to an increase in the category "Actual rentals for housing" (0.1%), which contributed to an effect of 0.02 ppts.

The decrease in the "Transport" sector was caused by a decrease of 1.5% in the category "Operation of personal transport equipment", which contributed to an effect of -0.13 ppts. The decrease in the "Communications" sector was due to a decrease in the category "Telephone and telefax services" (-0.7%), which contributed to an effect of -0.04 ppts.

The consumption basket of the CPI consists of 452 goods and services. Compared to September 2016, 30.5% of these products had an increase in price, causing an effect of 0.61 ppts, while 28.3% showed a decrease, contributing to an effect of -0.39 ppts and the remaining 41.2% had no change in price. The prices of goods increased by 0.4% and caused an influence of 0.25 ppts. The prices of services show a decrease of 0.1% and had an influence of -0.03 ppts on the CPI of October 2016.

The CPIC (core inflation) - CPI excluding the effect of energy and food – was 0.8% in October 2016, which is 0.4 ppts lower compared to the percentage change for the same period of last year (1.2%). The energy index - which consists of the products: electricity, water, gasoline and diesel – is -7.3%, which is 5.6 ppts lower compared to the percentage change for the same period of last year (-1.7%). The food index shows a decrease of 0.7%, which is 4.0 ppts lower compared to the percentage change for the same period of last year (3.3%).

The subsistence level for a household consisting of two (2) adults and two (2) children (aged 0-14 years) in October 2016 is Afl. 4,365, while for a single adult household it is Afl. 2,079.



Change in prices of crude oil, utilities, gasoline and diesel in October 2016

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In October 2016 the average price per barrel of crude oil (US\$ 49.92) had an increase of US\$ 4.61 (10.2%) compared to September 2016 (US\$ 45.31).

Fuel surcharge for a usage of electricity up to 500 kWh did not change in October 2016, it stayed at Afl. 21.90 cents per kWh. Fuel surcharge for a usage of electricity between 501 - 1000 kWh did not change in October 2016, it stayed at Afl. 27.80 cents per kWh. The prices of electricity and water did not change compared to September 2016. Subsequently, the average electricity price per household remained at Afl. 308.76, while the average price of water per household remained at Afl. 137.05.

In October 2016 the price of gasoline decreased by Afl. 2.30 cents (-1.3%) causing an effect of -0.07 ppts on the CPI. The price of diesel registered an increase of Afl. 0.40 cents (0.3%) and had an insignificant effect on the CPI of October 2016.

In October 2016, utilities, gasoline and diesel as a group show a decrease in price of 0.4% compared to September 2016, and had an influence of -0.07 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced an increase of 0.4% in price, causing an effect of 0.29 ppts on the CPI.

Change in prices of Food & catering services in October 2016

The "Food & catering services" index shows an increase of 1.5% in October 2016, after an increase of 0.3% in September 2016. The index for "Food at home" shows an increase of 1.9% in October, as seven (7) of the eleven (11) "Food at home" indices increased in October 2016. The "Fruit" index registered the largest increase (14.3%) in October 2016. Furthermore, increases were posted in the indices for "Vegetables" (5.3%), "Potatoes and other tubers" (0.9%) and "Sugar, jam, honey and other confectionery" (0.3%). The "Fish and other seafood" index registered the largest decrease (-1.1%). Furthermore, decreases of 0.6%, 0.1% and 0.1% were posted in the indices for "Meat", "Food products n.e.c." and "Oils and fats", respectively.

Over the last twelve (12) months the "Food & catering services" index has increased by 1.0%. The "Food at home" index shows an increase of 1.1%. The "Fruit" index increased by 24.2%, the largest increase among the "Food at home" food groups, while the "Milk, cheese and eggs" index shows the largest decrease (-5.8%).

The index for "Food away from home" shows an increase of 0.02% in October 2016 after being unchanged in September 2016 and has increased by 0.8% over the last twelve (12) months.

In October 2016, "Food at home" and "Food away from home" as a group show an increase in price of 1.5% compared to September 2016, and had an influence of 0.27 ppts on the CPI, while the remaining goods and services, as a group, experienced a decrease in price of 0.1%, causing an effect of -0.05 ppts on the CPI.
