

Foreign Trade, 2nd Quarter 2017

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 2nd quarter 2017.

Total Import

The total import, in terms of weight, registered an increase of 0.5% in the second quarter of 2017 (151.6 mln kg) compared to the same period in 2016 (150.8 mln kg), while, in terms of value, it increased by 8.6% from Afl. 469.5 mln to Afl. 509.8 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered an increase of 0.5% in the second quarter of 2017 (149.9 mln kg) compared to the same period in 2016 (149.2 mln kg). During this period eleven (11) of the twenty-one (21) sections, in terms of weight, registered increases in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Works of stone, gypsum, cement, asbestos" (1.5 mln. kg), "Miscellaneous manufactured articles" (0.6 mln. kg) and "Transport equipment" (0.5 mln. kg).

The largest decrease is seen for the section "Mineral products" (-1.2 mln. kg).

Import to the free circulation area of Aruba (value)

Import to the free circulation area of Aruba, in terms of value, registered an increase of 8.5% in the second quarter of 2017 (Afl. 490.1 mln) compared to the same period in 2016 (Afl. 451.6 mln). Twelve (12) of the twenty-one (21) sections, in terms of value, registered increases in import to the free circulation area of Aruba.

The largest increase is seen for the section "Miscellaneous manufactured articles" (Afl. 7.8 mln). Furthermore, increases of Afl. 6.3 mln, Afl. 6.2 mln and Afl. 5.9 mln were registered for the "Base metals and derived works", "Machinery & electro technical equipment (new & renewed)" and "Mineral products" sections, respectively.

The largest decreases are observed for the sections "Food products" (Afl. -2.3 mln), "Works of art, collectors pieces and antiques" (Afl. -1.0 mln.) and "Textile fibers and articles" (Afl. -0.7 mln).

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba by Sea

Import by Sea to the free circulation area of Aruba, in terms of **weight**, registered an increase of 0.6% in the second quarter of 2017 (149.3 mln kg) compared to the same period in 2016 (148.4 mln kg), while, in terms of **value**, it increased by 9.6% from Afl. 369.8 mln to Afl. 405.4 mln. The changes in the sections in this category (Import by Sea) represent for the greater part the changes in the total Import to the free circulation area of Aruba.


2. Import to the free circulation area of Aruba by Air

Import by Air to the free circulation area of Aruba, in terms of **weight**, decreased by 10.7% from Afl. 0.75 mln in the second quarter of 2016 to Afl. 0.67 mln in the second quarter of 2017, while, in terms of **value**, it increased by 3.5% from Afl. 81.8 mln to Afl. 84.7 mln.

Import to the free circulation area of Aruba by Large companies**

Import by "Large companies", in terms of **weight**, decreased by 8.7% from 25.3 mln kg in the second quarter of 2016 compared to 23.1 mln kg in the second quarter of 2017, while, in terms of **value**, it increased by 23.2% from Afl. 38.9 mln to Afl. 47.9 mln.

Total Export

The total export, in terms of **weight**, registered an increase of 2.0% in the second quarter of 2017 (5.7 mln kg) compared to the same period of 2016 (5.6 mln kg), while, in terms of **value**, it decreased by 8.5% from Afl. 45.4 mln to Afl. 41.6 mln.

Export from the free circulation area of Aruba (weight)

Eleven (11) of the twenty-one (21) sections, in terms of weight, registered decreases in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Mineral products" (-0.7 mln. kg), "Machinery & electro technical equipment (new & renewed)" (-0.1 mln. kg) and "Transport equipment" (-0.1 mln. kg).

The largest increases are observed for the sections "Base metals and derivated works" (0.3 mln kg) and "Materials for the manufacture of paper, paperwork" (0.2 mln kg).

Export from the free circulation area of Aruba (value)

Twelve (12) of the twenty-one (21) sections, in terms of value, registered decreases in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Real pearls (natural) and other precious stones" (Afl. -2.0 mln), "Works of art, collector's pieces and antiques" (Afl. -1.3 mln) and "Optical instruments, apparatus and equipment" (Afl. -0.9 mln).

The largest increase is seen for the section "Base metals and derivated works" (Afl. 2.0 mln). Furthermore, increases of Afl. 1.2 mln, Afl. 0.3 mln and Afl. 0.3 mln were registered for the "Chemical products", "Footwear, headgear and umbrellas" and "Food products".

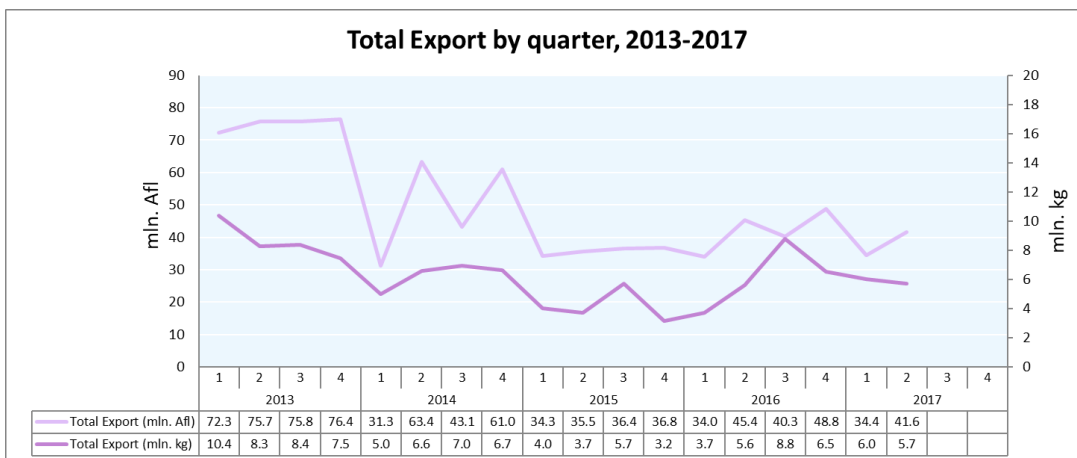
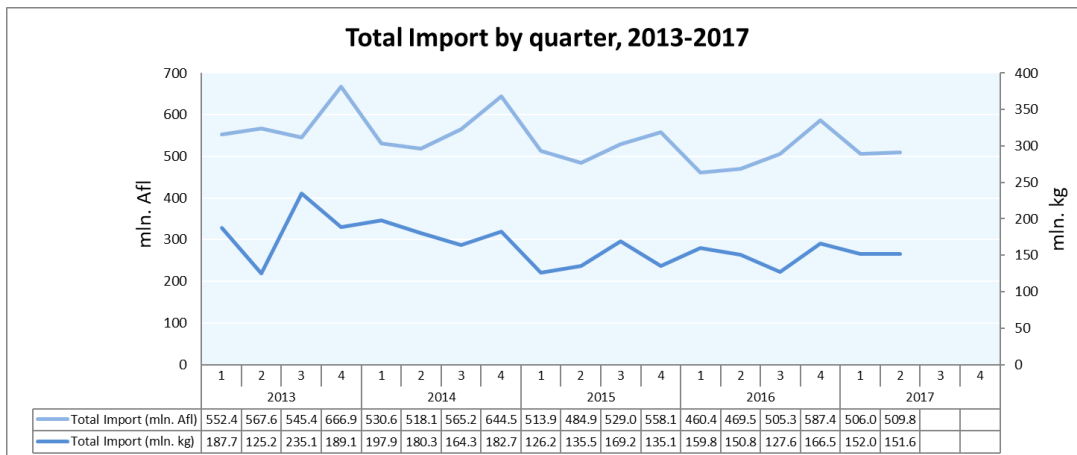
