

Foreign Trade, 3rd Quarter 2017

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 3rd quarter 2017.

Total Import

The total import, in terms of weight, registered an increase of 19.9% in the third quarter of 2017 (153.0 mln kg) compared to the same period in 2016 (127.6 mln kg), while, in terms of value, it decreased by 2.3% from Afl. 505.3 mln to Afl. 493.7 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered an increase of 20.8% in the third quarter of 2017 (151.2 mln kg) compared to the same period in 2016 (125.2 mln kg). During this period eleven (7) of the twenty-one (21) sections, in terms of weight, registered increases in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Mineral products" (25.7 mln. kg), "Base metals and derivated works" (1.0 mln. kg) and "Live animals and other animal products" (0.6 mln. kg).

The largest decrease is seen for the section "Food products" (-0.9 mln. kg).

Import to the free circulation area of Aruba (value)

Import to the free circulation area of Aruba, in terms of value, registered a decrease of 1.2% in the third quarter of 2017 (Afl. 474.5 mln) compared to the same period in 2016 (Afl. 480.2 mln). Twelve (12) of the twenty-one (21) sections, in terms of value, registered decreases in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Miscellaneous manufactured articles" (Afl. -4.4 mln), "Transport equipment" (Afl. -3.5 mln.) and "Machinery and electrotechnical equipment (new & renewed)" (Afl. -2.0 mln).

The largest increase is seen for the section "Live animals and other animal products" (Afl. 6.3 mln). Furthermore, increases of Afl. 1.8 mln, Afl. 1.3 mln and Afl. 1.2 mln were registered for the "Chemical products", "Materials for the manufacture of paper, paperwork" and "Real pearls (natural) and other precious stones."

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba by Sea

Import by Sea to the free circulation area of Aruba, in terms of **weight**, registered an increase of 21.0% in the third quarter of 2017 (150.6 mln kg) compared to the same period in 2016 (124.5 mln kg), while, in terms of **value**, it decreased by 0.9% from Afl. 399.3 mln to Afl. 395.7 mln. The changes in the sections in this category (Import by Sea) represent for the greater part the changes in the total Import to the free circulation area of Aruba.


2. Import to the free circulation area of Aruba by Air

Import by Air to the free circulation area of Aruba, in terms of **weight**, decreased by 19.2% from 0.75 mln kg in the third quarter of 2016 to 0.60 mln kg in the third quarter of 2017, while, in terms of **value**, it decreased by 2.6% from Afl. 80.9 mln to Afl. 78.8 mln.

Import to the free circulation area of Aruba by Large companies**

Import by "Large companies", in terms of **weight**, decreased by 31.7% from 24.9 mln kg in the third quarter of 2016 compared to 17.0 mln kg in the third quarter of 2017, while, in terms of **value**, it decreased by 11.8% from Afl. 43.7 mln to Afl. 38.6 mln.

Total Export

The total export, in terms of **weight**, registered a decrease of 16.9% in the third quarter of 2017 (8.8 mln kg) compared to the same period of 2016 (10.7 mln kg), while, in terms of **value**, it increased by 2.9% from Afl. 40.3 mln to Afl. 41.4 mln.

Export from the free circulation area of Aruba (weight)

Thirteen (13) of the twenty-one (21) sections, in terms of weight, registered decreases in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Mineral products" (-3.3 mln. kg) and "Fats and oils" (-0.2 mln. kg).

The largest increases are observed for the sections "Base metals and derived works" (1.7 mln kg) and "Materials for the manufacture of paper, paperwork" (0.6 mln kg).

Export from the free circulation area of Aruba (value)

Five (5) of the twenty-one (21) sections, in terms of value, registered increases in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Base metals and derived works" (Afl. 6.3 mln), "Chemical products" (Afl. 1.5 mln) and "Wood, charcoal and woodwork" (Afl. 0.2 mln).

The largest decrease is seen for the section "Machinery and electrotechnical equipment (new & renewed)" (Afl. -0.9 mln). Furthermore, decreases of Afl. 0.7 mln and Afl. 0.5 mln were registered for the "Skins, hides, leather and peltry" and "Artificial plastic elements".

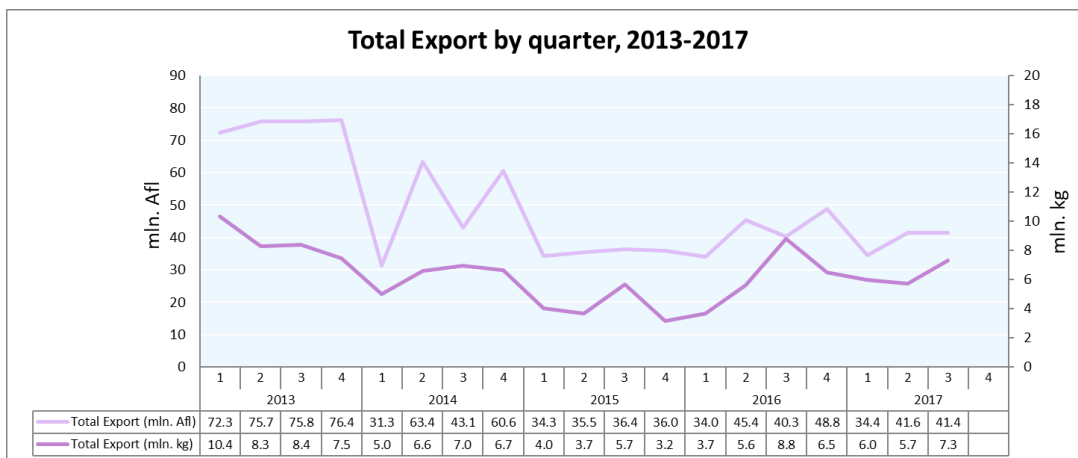
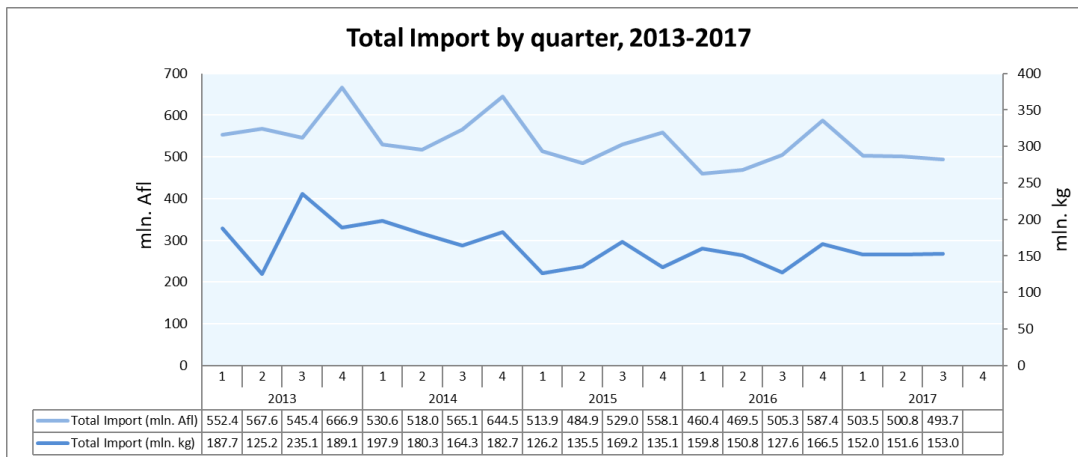
