A note to the reader

The following report presents the price statistics for October 2012.

- At the end of October 2012 the Consumer Price Index (CPI) shows a decrease of 0.1% compared to the end of September 2012. The sector which affected the CPI the most was “Recreation and culture” (-0.7%), which led to an effect of -0.06 percentage points (ppts) on the Δ CPI of October 2012 (-0.1%).
- Compared to October 2011 the CPI decreased by 1.6%. Over the last 12 months the sector which affected the CPI the most was “Housing” (-5.5%). Specifically, the price of “Water supply and miscellaneous services relating to the dwelling” decreased by 27.0% and caused an effect of -1.85 ppts on the end of period inflation of October 2012 (-1.6%).
- The period average inflation for the period October 2011 - October 2012 is 2.2%, which is 1.0 ppt lower compared to the period average inflation for the period October 2010 - October 2011 (3.2%).
- Utilities (Water and Electricity) did not register price changes in October 2012. In October increases of 1.7% and 0.1% were registered in the prices of diesel and gasoline respectively, causing together an effect of 0.01 ppt on the CPI.

This report is divided in 6 sections. An overview of the monthly percentage changes in the CPI and index per sector is presented in section 1. Section 2 provides the yearly percentage changes in the CPI and index per sector. The development of indices of main sectors and utilities is outlined in section 3. Section 4 presents the percentage change in the CPI of Aruba’s major trading partners and compares the CPI of Aruba and the USA. Section 5 presents an overview of the monthly and yearly percentage changes of the core inflation. Section 6 presents the price movements in food & catering services and is followed by the appendices.

1 Monthly change of the CPI

1.1 CPI and Inflation

The CPI of the total population of Aruba for the month of October 2012 is 119.3; a decrease of 0.1% compared to the CPI of September 2012 (119.4). An overview of the percentage change in the CPI (Δ CPI) for different periods during 2011 and 2012 is shown in Table 1. The terms percentage change in the CPI and “inflation” (deflation) are considered similar and are used interchangeably. The deflation over the last 12 months (end of period inflation) is 1.6%, while the inflation over a period of 24 months (period average inflation) is 2.2%.




Figure 2: Monthly Δ CPI for October, 2003 - 2012

Figure 1 depicts the monthly Δ CPI over a period of one year starting from October 2011, whereas the Δ CPI for the month October for the years 2003 to 2012 is illustrated in Figure 2.

1.2 Changes in sector





Figure 3: Δ I per sector, October 2012

Figure 3 provides an overview of the percentage changes for the indices per sector for October 2012. The percentage change in index is further denoted as Δ I. The largest Δ I is observed for the sector “Clothing and footwear” (-0.8%).

1.3 Changes in categories and subcategories

The largest positive and negative Δ I is seen in the categories “Accommodation services” (5.6%) and “Audio-visual, photographic and information processing equipment” (-3.8%), respectively. The “Recreation and culture” sector registered a decrease of 0.7%, while the “Food and non-alcoholic beverages” sector decreased by 0.2%. In the “Transport” sector the major Δ I is observed for the category “Transport services” (2.0%), which is mainly the result of an increase in “Plane tickets” of 5.2%¹.

The categories which influenced the CPI calculation the most are “Audio-visual, photographic and information processing equipment”, “Food”, “Transport services” and “Clothing”, which had an effect of respectively, -0.04, -0.03, 0.03 and -0.03 ppts on the Δ CPI. Reference is made to tables 13 and 14 in Appendices 1 and 2. Table 13 provides an overview of the indices for the months October 2011, December 2011, September 2012 and October 2012 together with corresponding weights per sector and the monthly, year-to-date (ytd), end of period and period average percentage changes for October 2012. In table 14 an overview of the effect on

the monthly, ytd, end of period and period average CPI per sector and category for October 2012 is presented. The course of indices for 2006 up to October 2012 is illustrated in Appendix 4.

Figure 1: Monthly Δ CPI, 2011 - 2012

2 End of period change of the CPI

2.1 End of period change CPI for October 2012

The CPI decreased from 121.3 in October 2011 to 119.3 in October 2012, a decrease of 1.6%. This Δ CPI is the second lowest registered over a period of 5 years for the month October, and is 8.1 ppts lower than the Δ CPI registered in 2011 (6.5%) (see table 2).

2.2 Changes in sector


Figure 4: Δ I per sector

An overview of the percentage change per sector over the period October 2011 - October 2012 is presented in table 3. The largest Δ I is observed for the sector "Clothing and footwear" with a decrease of 11.3%. The decrease in the "Clothing and footwear" sector was mainly caused by a decrease in the category "Clothing" (-11.6%). Furthermore, decreases of 5.5% and 5.2% are observed for the sectors "Housing" and "Household operation" respectively. A comparison of the Δ I's for the years 2011 and 2012 is provided in figure 4.



2.3 Changes in categories

The largest positive and negative Δ I in categories observed over a period of one year are respectively, "Postal services" (7.5%) and "Other major durables for recreation and culture" (-28.9%). For an overview of the end of period percentage changes per category refer to table 13 in Appendix 1.

2.4 End of year change CPI 2003 - 2012

The end of year Δ CPI for the period 2003 - 2012 is shown in figure 5. The Δ CPI for 2012 is calculated by comparing the CPI of October 2012 with the CPI of December 2011. At the end of each year, the end of year percentage change equals the ytd Δ CPI. The ytd Δ CPI for October 2012 is -1.7%.

2.5 Period average change CPI for October 2012

The period average change CPI (Δ ACPI) for October 2012 is 2.2%. Table 4 provides an overview of the Δ ACPI for the month October for the years 2008 to 2012. The Δ ACPI for 2012 decreased by 1.0 ppt compared to 2011.

3 Development of indices of main sectors and utilities

3.1 Indices main sectors

The four major sectors, “Housing”, “Transport”, “Food and non-alcoholic beverages” and “Recreation and culture”, constitute 64% of the total weight of the basket of goods and services, which are observed on a monthly basis. An overview of the course of indices for 2006 up to October 2012 per sector and for the CPI is provided in figures 9-1 to 9-12 in Appendix 4.





Figure 6-2 Gasoline, diesel and crude oil prices, 2008 - 2012

Changes in the indices of the sectors “Housing” and “Transport” are mainly the result of changes in the international oil prices and prices of utilities during the respective months. The development of indices of fuel surcharge, electricity, water, gasoline and diesel prices is provided in table 5 and in the adjoining figures 6-1 and 6-2.

3.2 Electricity

The price of electricity is determined in Aruban florins (Afl.) for an average usage by households. The average usage is 725.5 kWh per month. The electricity price for an average consumption of 725.5 kWh did not change in October 2012, it remained at Afl. 363.27. Figure 6-1 provides an overview of the course of changes in the electricity price for the period 2008 to 2012.

The component in the electricity tariff which is sensitive to price changes is the fuel surcharge (brandstofclausule). Fuel surcharge for a usage of electricity up to 500 kWh did not change in October 2012, it stayed at 32.49 cents per kWh. Fuel surcharge for usage of each kWh above 500 kWh did not change either in October 2012, it stayed at 38.47 cents per kWh. Figure 6-1 shows these components of the electricity tariff in Afl. per kWh per month.

3.3 Water

The price of water is determined in Afl. for an average usage (water consumption) by households. Figure 6-1 provides an overview of the course of changes in the water price for the period 2008 to 2012. The water price for an average usage by households did not change in October 2012, it remained at Afl. 137.05.

3.4 Gasoline and Diesel

The retail price of gasoline increased by 0.1% from 244.7 cents per liter in September 2012 to 244.9 cents per liter in October 2012. In October 2012, the retail price of diesel registered an increase of 1.7% from 214.4 cents per liter in September 2012 to 218.1 cents per liter.

Figure 6-1 Electricity price, water price and fuel surcharge in Afl., 2008 - 2012

4 Percentage change CPI of Aruba's major trading partners

4.1 Comparison of the CPI of Aruba and the USA

Table 6 provides an overview of the Δ CPI of Aruba's major trading partners starting from October 2011. In October 2012 the Δ CPI of the USA, Curaçao and the Netherlands were respectively 0.0%, 0.7% and 0.6%.

The USA is considered Aruba's largest trading partner². Table 7 provides an overview of the Δ CPI for Aruba and the USA for 2012. Aruba's monthly Δ CPI for October 2012 is 0.1 ppt lower than the Δ CPI of the USA.





Figure 8: End of year Δ CPI, 2002 - 2012

The Δ CPI of Aruba over the last 12 months is 3.8 ppts lower compared to the USA's 12-month Δ CPI. The Δ CPI over the last 24 months for Aruba is 0.1 ppt lower than the Δ CPI of the USA. The monthly inflation for both Aruba and the USA is depicted in figure 7 over a period of one year. Furthermore, an overview of the end of year Δ CPI over the period 2002 - 2012 for Aruba and the USA is provided in table 8 and figure 8.

Figure 7: Monthly Δ CPI for Aruba and the USA, 2011 - 2012

5 Core inflation

5.1 Core inflation

Core inflation is a measure of inflation which excludes certain items that face volatile price movements e.g. food products and energy. By calculating the core inflation these more volatile components are eliminated from the inflation. Core inflation indices serve to assess the mid- and long-term trend of the overall price level. For the purpose of adjusting monetary policy, many economists focus more intently on the core rate of inflation, as this allows for an in-depth assessment of inflationary processes ongoing in the economy.

5.2 Monthly change of the core inflation

In October 2012 the core inflation (measured over the period October 2011 - 2012) was 0.6%, 0.5 ppts lower compared to October 2011. In October 2012 the food index shows an increase of 3.7%, while the energy index had an increase of 6.4%. Over the past year the food index increased by 0.4 ppts and the energy index decreased by 3.9 ppts. Table 9 provides an overview of the monthly inflation and core inflation starting from October 2011.



5.3 End of year change of the core inflation, 2007 - 2012

The end of year core inflation of the total population of Aruba for the year 2012 (up to October) is 0.6%, 1.1 ppts lower than the core inflation of 2011. Table 10 provides an overview of the end of year inflation and core inflation over the period 2007 - 2012.



6 Development of Food & catering services

6.1 Monthly change of Food & catering services for October 2012

The “Food & catering services” index decreased with 0.1% in October 2012 after increasing 0.2% in September 2012. The index for “Food at home” shows a decrease of 0.2% in October, as four of the eleven “Food at home” indices decreased in October 2012. The “Potatoes and other tubers” index registered the largest decrease (-6.4%) in October and was caused by a decrease in the index for “Potatoes” (-8.4%). The “Vegetables” index decreased by 1.8%, after increasing 2.4% the previous month. The index for “Bread and cereals” shows a decrease of 0.6%. The index for “Milk, cheese and eggs” decreased by 0.2%, its seventh consecutive decrease. The “Sugar, jam, honey and other confectionery” index increased the most (0.6%), followed by increases of 0.5%, 0.4% and 0.3% in the indices for “Food products n.e.c.”, “Meat” and “Fruit”, respectively.

Table 11 provides an overview of the corresponding weights per food group together with the percentage changes and effect for October 2012.

Reference is made to table 15 in Appendix 3. Table 15 provides an overview of the monthly and end of period percentage changes and effect for October 2012 for the food groups.

In October 2012, “Food at home” and “Food away from home” as a group show a decrease in price of 0.2% compared to September 2012, and had an influence of -0.03 ppts on the CPI, while the remaining goods and services, as a group, experienced a decrease in price of 0.1%, causing an effect of -0.07 ppts on the CPI.



6.2 End of Period change of Food & catering services for October 2012

Over the last 12 months the “Food & catering services” index has increased by 1.4%. The “Food at home” index shows an increase of 0.5%. The “Fish and other seafood” index increased by 6.1%, the largest increase among the “Food at home” food groups, while the “Potatoes and other tubers” index (-14.1%) shows the largest decrease. The index for “Food away from home” was unchanged in October 2012, after increasing 0.1% in September, and has increased by 4.4% over the last 12 months.



Glossary

The Consumer Price Index and Inflation

The Consumer Price Index (CPI) measures changes in prices of consumer goods and services by households. Consumer price indices can be intended to measure either the rate of price inflation or deflation as perceived by households or changes in their cost of living. In case of inflation, the percentage change is positive and it indicates a decrease in the purchasing power of the consumers.

Monthly percentage change

Percentage change in price indices of any aggregates of the CPI in relation to the respective price indices of the previous month.

Year-to-date (ytd)

Percentage change in price indices of any aggregates of the CPI in relation to the respective price indices of December prior to the year under review.

End of period inflation (last 12 months)

Percentage change in price indices of any aggregates of the CPI in relation to the respective price indices of the same month of the previous year.

Period average inflation (last 24 months)

The end of period inflation percentage change in CPI (period average inflation) is calculated by comparing the annual average CPI of the concerning period with the annual average CPI of the concerning period of the previous year.

Effect

Contribution of all percentage changes (of all respective aggregates) to the CPI.

Core inflation

Core inflation is a measure of inflation that excludes certain items which face volatile price movements. Core inflation eliminates the inflation of certain products that can have temporary price shocks because these shocks can diverge from the overall trend of inflation and give a false measure of inflation. The core rate of inflation is calculated by: total inflation excluding food and energy prices. In part, that is because the core is less volatile and reflects better the relationship of supply and demand in domestic product markets. The core usually is a better measure of the basic rate of inflation that will tend to emerge in the absence of supply shocks.

Food & catering services

The “Food & catering services” index is composed of the indices for the “Food & Non-alcoholic beverages” sector (“Food at home”) and the “Catering services” (“Food away from home”) category.
