

## Consumer Price Index, base period December 2006 August 2009

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of August 2009.

## **Overview Consumer Price Indices**

- The CPI for August 2009 is 114.51, a decrease of 0.13% compared to the index of July 2009 (114.66).
- The percentage change for the first 8 months (January to August 2009) of the CPI is 6.15, 3.14 percentage points (ppts) lower compared to 9.29 for the same period of last year.
- The percentage change of the CPI over the last 12 months (August 2008 to August 2009) is -4.68, a decrease of 17.34 ppts compared to the percentage change for the same period of last year (12.66).
- The period average percentage change of the CPI for the period August 2008 - August 2009 is -0.20, a decrease of 9.59 ppts compared to the period average percentage change over the period August 2007 - August 2008 (9.39).

## **Monthly Percentage Change**

The consumption basket of the CPI consists of 452 goods and services. Compared to July 2009, 40.9% of these products had an increase in price, while 25.4% showed a decrease and the remaining 33.6% had no change in price.

The prices of all products (goods and services) in the consumption basket of the CPI show a decrease of 0.13% for the month of August 2009 compared to the prices observed in July 2009.

The prices of goods decreased by 0.25% and caused an influence of -0.17 ppts on the percentage change of the CPI. The prices of services show an increase (0.10%) and had an influence of 0.04 ppts on the CPI.

In August 2009, the sectors that had the greatest influence on the percentage change of the CPI are:

- Transport (-0.24), where a decrease in prices was mainly registered in the category "Operation of personal transport equipment".
- Household operation (0.09), where an increase in prices was mainly registered in the category "Goods and services for routine household maintenance and cleaning".
- Food and non-alcoholic beverages (-0.08), where a decrease in prices was registered in the category "Food".
- Housing (0.06), where increases in prices were registered in the categories "Actual rentals for housing" and "Maintenance and repair of the dwelling".
- Recreation and culture (-0.06), where a decrease in prices was registered in the category "Holidays", which was partially offset by an increase in prices in the category "Other recreational items and equipment; gardens and pets".


 Clothing and footwear (0.05), where an increase in prices was registered in the category "Clothing".

Graph 1 shows that the monthly percentage change of the CPI decreased by 1.95 ppts to -0.13 in August of 2009 from 1.82 in August of 2008.

## Change in prices of utilities and gasoline in August 2009

Fuel surcharge did not change in August, it stayed at Afl. 25.56 cents per kWh. The prices of electricity and water did not change either compared to July 2009, subsequently the average electricity price remained at Afl. 299.51, while the price of water remained at Afl. 156.40.

The price of gasoline shows a decrease for the first time since January 2009. In August 2009 it decreased by Afl. 0.08 (-4.15%) causing an effect of -0.24 ppts on the CPI. The price of diesel also registered a decrease in August 2009. Compared to July 2009 it decreased by Afl. 0.04 (-2.77%) causing an effect of -0.01 ppt on the CPI.

In August 2009, utilities, gasoline and diesel as a group show a decrease in prices of 1.23% compared to July 2009, and had an influence of -0.24 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced an increase in prices of 0.14%, causing an effect of 0.11 ppts on the CPI.
