

## Consumer Price Index, base period December 2006 August 2011

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of August 2011.

The CPI for August 2011 is 122.25, an increase of 1.64% compared to the index of July 2011 (120.27) and accumulating an increase of 6.90% up to and including August of this year.

The percentage change of the CPI over the last 12 months (August 2010 to August 2011) is 6.85, an increase of 6.94 percentage points (ppts) compared to the percentage change for the same period of last year (-0.09).

The period average percentage change of the CPI for the period August 2010 - August 2011 is 2.07, a decrease of 0.27 ppts compared to the period average percentage change over the period August 2009 - August 2010 (2.34).

During this month, ten of the twelve sectors registered increases in prices. The increases which had the greatest influence on the CPI were registered for the "Housing" (3.89%), "Transport" (1.44%) and "Recreation and culture" (0.80%) sectors, causing an effect of respectively 1.16, 0.26 and 0.07 ppts. The increases in the remaining sectors had a total effect of 0.16 ppts on the CPI of August 2011.


Aforementioned increases were partially offset by decreases in the indices for the "Clothing and footwear" (-0.09%) and "Health" (-0.14%) sectors, which together had a minimal influence of -0.01 ppt.

The increase in the "Housing" sector was mainly due to increases in the categories "Water supply and miscellaneous services relating to the dwelling" (11.91%) and "Electricity, gas and other fuels" (3.77%), which contributed to an effect of respectively 0.73 and 0.37 ppts. The increase in the "Transport" sector was mainly the result from an increase in the category "Operation of personal transport equipment" (2.78%), which had an influence of 0.27 ppts. The increase in the "Recreation and culture" sector was mainly caused by an increase of 6.36% in the category "Holidays", which contributed to an effect of 0.05 ppts.

The decrease in the "Clothing and footwear" sector was caused by declines of respectively 0.32% and 0.06% in the categories "Footwear" and "Clothing", which together contributed to an effect of -0.01 ppt.

The consumption basket of the CPI consists of 452 goods and services. Compared to July 2011, 42.3% of these products had an increase in price, while 30.3% showed a decrease and the remaining 27.4% had no change in price. The prices of goods increased by 2.18% and caused an influence of 1.44 ppts. The prices of services show an increase of 0.60% and had an influence of 0.20 ppts.

The CPIC (core inflation) - CPI excluding the effect energy and food - registered in August 2011 an increase of 0.52%, which is 0.25 ppts lower compared to the percentage change for the same period of last year (0.77%). The energy index - which consists of the products: electricity, water, gasoline and diesel - registered an increase of 7.50%, which is 3.97 ppts lower compared to the percentage change for the same period of last year (11.47%). The food index shows an increase of 1.79%, which is 4.50 ppts higher compared to the percentage change for the same period of last year (-2.71%).

## Change in prices of crude oil, utilities, gasoline and diesel in August 2011

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In August 2011 the average price of crude oil per barrel (US\$ 106.30) had a decrease of US\$ 4.88 (-4.39%) compared to July 2011 (US\$ 111.18).

Effective August 1, 2011 ELMAR announced the introduction of a new model for calculating the price of electricity. Whereas prior to this model, one fuel surcharge tariff was used for calculating the electricity price, as of August 1, 2011 two tariffs are used: 1. Fuel surcharge for a usage of electricity up to 500 kWh and 2. Fuel surcharge for usage of each kWh above 500 kWh. Fuel surcharge for a usage up to 500 kWh was set at Afl. 32.49 cents per kWh, while fuel surcharge for each kWh above 500 kWh was set at Afl. 38.47 cents. The price of electricity, which is based on an average household usage of 725.5 kWh, shows an increase in price compared to July 2011. The average electricity price per household increased to Afl. 363.27 (3.86%) causing an effect of 0.37 ppts on the CPI. The price of water also shows an increase in price compared to July 2011, the average price of water per household increased to Afl. 195.47 (13.25%) causing an effect of 0.73 ppts on the CPI.

In August 2011 the price of gasoline increased by Afl. 0.08 (3.40%) causing an effect of 0.23 ppts on the CPI. The price of diesel registered an increase of Afl. 0.04 (2.13%) and had an effect of 0.01 ppt on the CPI of August 2011.

In August 2011, utilities, gasoline and diesel as a group show an increase in price of 6.05% compared to July 2011, and had an influence of 1.34 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced an increase in price of 0.39%, causing an effect of 0.30 ppts on the CPI.
