

## Consumer Price Index, base period December 2006 August 2013

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of August 2013.

The CPI for August 2013 is 117.50, an increase of 0.1% compared to the index of July 2013 (117.35) and accumulating an increase of 0.6% up to and including August of this year.

The percentage change of the CPI over the last 12 months (August 2012 to August 2013) is -1.1, an increase of 1.7 percentage points (ppts) compared to the percentage change for the same period of last year (-2.8).

The period average percentage change of the CPI for the period August 2012 - August 2013 is -3.0, a decrease of 6.6 ppts compared to the period average percentage change over the period August 2011 - August 2012 (3.6).

During this month, five of the twelve sectors registered increases in prices. The increases which had the greatest influence on the CPI were registered for the "Transport" (1.0%) and "Food and non-alcoholic beverages" (0.4%) sectors, causing an effect of respectively 0.19 and 0.05 ppts. The increases in the remaining sectors had a total effect of 0.02 ppts on the CPI of August 2013. Aforementioned increases were partially offset mainly by decreases in the indices for the "Clothing and footwear" (-1.6%) and "Recreation and culture" (-0.5%) sectors, which had an influence of -0.08 and -0.04 ppts, respectively. The decreases in the remaining sectors had a total effect of -0.02 ppts on the CPI of August 2013.

The increase in the "Transport" sector was due to an increase in the category "Operation of personal transport equipment" (3.4%), which contributed to an effect of 0.33 ppts. The increase in the "Food and non-alcoholic beverages" sector was caused by an increase in the category "Food" (0.5%), causing an effect of 0.05 ppts.

The decrease in the "Clothing and footwear" sector was mainly caused by a decrease of 1.4% in the category "Clothing", which contributed to an effect of -0.06 ppts. The decrease in the "Recreation and culture" sector was mainly caused by decreases in the categories "Audio-visual, photographic and information processing equipment" (-2.8%) and "Other recreational items and equipment; gardens and pets" (-1.5%), causing an effect of -0.03 and -0.05 ppts, respectively.

The consumption basket of the CPI consists of 452 goods and services. Compared to July 2013, 33.4% of these products had an increase in price, causing an effect of 0.61 ppts, while 30.5% showed a decrease, contributing to an effect of -0.48 ppts and the remaining 36.1% had no change in price. The prices of goods increased by 0.3% and caused an influence of 0.21 ppts. The prices of services show a decrease of 0.2% and had an influence of -0.08 ppts.

The CPIC (core inflation) - CPI excluding the effect of energy and food - registered in August 2013 a slight increase of 0.02%, which is 1.1 ppts lower compared to the percentage change for the same period of last year (1.1%). The energy index - which consists of the products: electricity, water, gasoline and diesel - registered a decrease of 13.0%, which is 23.9 ppts lower compared to the percentage change for the same period of last year (10.9%). The food index shows a decrease of 0.1%, which is 4.9 ppts lower compared to the percentage change for the same period of last year (4.8%).

The subsistence level for a household consisting of two adults and two children (aged 0-14 years) in August 2013 is Afl. 4,271, a decrease of Afl. 77, compared to August 2012 (Afl. 4,348), while for a single adult household the amount is Afl. 2,034, a decrease of Afl. 37, compared to August 2012 (Afl. 2,071).



## Change in prices of crude oil, utilities, gasoline and diesel in August 2013

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In August 2013 the average price per barrel of crude oil (US\$ 106.30) had an increase of US\$ 1.77 (1.7%) compared to July 2013 (US\$ 104.53).

Fuel surcharge for a usage of electricity up to 500 kWh did not change in August 2013, it stayed at Afl. 24.60 cents per kWh. Fuel surcharge for a usage of electricity between 501 - 1000 kWh did not change in August 2013, it stayed at Afl. 30.90 cents per kWh. The prices of electricity and water did not change compared to July 2013. Subsequently, the average electricity price per household remained at Afl. 306.75, while the average price of water per household remained at Afl. 137.05.

In August 2013 the price of gasoline increased by Afl. 0.11 (4.6%) causing an effect of 0.30 ppts on the CPI. The price of diesel registered an increase of Afl. 0.07 (3.3%) and had an effect 0.01 ppt on the CPI of August 2013.

In August 2013, utilities, gasoline and diesel as a group show an increase in price of 1.6% compared to July 2013, and had an influence of 0.31 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced a decrease of 0.2% in price, causing an effect of -0.19 ppts on the CPI.

## Change in prices of Food & catering services in August 2013

The "Food & catering services" index increased by 0.3% in August 2013, after a decrease of 0.6% in July 2013. The index for "Food at home" shows an increase of 0.4% in August, as seven of the eleven "Food at home" indices increased in August 2013. The "Potatoes and other tubers" index registered the largest increase (5.6%) in August and was mainly caused by an increase of 7.4% in the index for "Potatoes". The "Vegetables" index increased by 2.9%. The indices for "Bread and cereals" and "Fish and other seafood" show both an increase of 0.4%. The "Food products n.e.c." index decreased the most (-1.1%), followed by decreases of 0.2 % and 0.1% in the indices for "Non-alcoholic beverages" and "Oils and fats", respectively.

Over the last 12 months the "Food & catering services" index has increased by 0.2%. The "Food at home" index was unchanged in August 2013. The "Fish and other seafood" index increased by 2.5%, the largest increase among the "Food at home" food groups, while the "Potatoes and other tubers" index shows the largest decrease (-12.5%).

The index for "Food away from home" was unchanged in August, after an increase of 0.2% in July 2013 and has increased by 1.1% over the last 12 months.

In August 2013, "Food at home" and "Food away from home" as a group show an increase in price of 0.3% compared to July 2013, and had an influence of 0.05 ppts on the CPI, while the remaining goods and services, as a group, experienced an increase in price of 0.1%, causing an effect of 0.07 ppts on the CPI.
