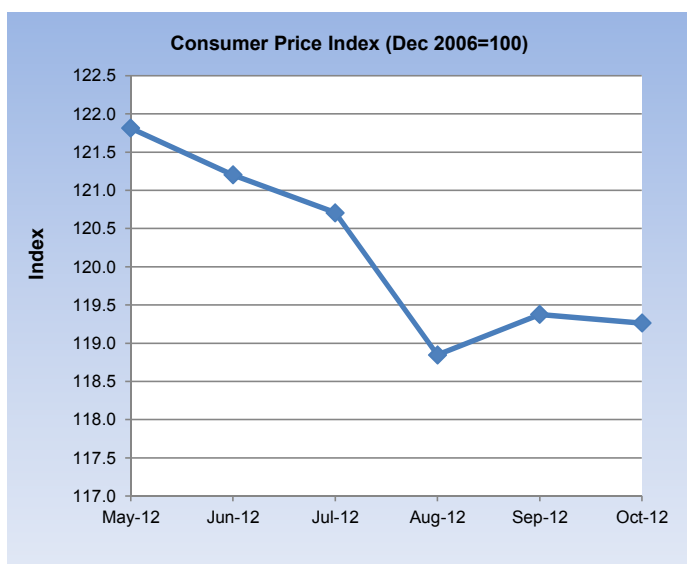

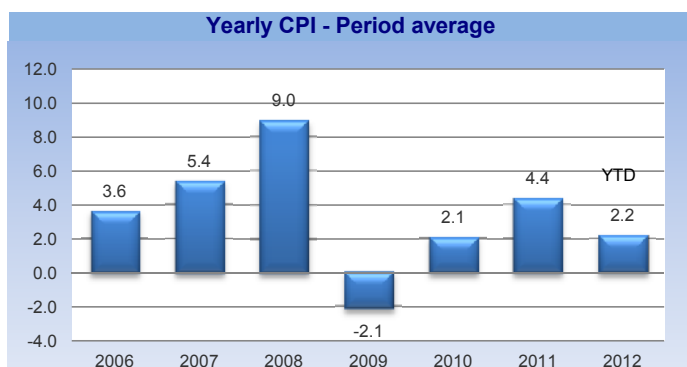

Key points

In October 2012, the total consumer price index decreased by 0.1 percent compared to the previous month. With the exception of Transport (+0.1%), Miscellaneous goods services (+0.1%) and Restaurants & Hotels (+0.1%), decreases in average prices have been recorded for Clothing & footwear (-0.8%), Recreation & culture (-0.7%), Food & non-alcoholic beverages (-0.2%), Household operation (-0.2%) and Health (-0.1%). At the end of October 2012, the twelve-month average rate of inflation was at 2.2 percent, down from 3.2 percent recorded at the end of October 2011.

On a yearly basis, consumer prices fell with 1.6 percent in October 2012. Major price increases were recorded in the following sectors:

1. **Housing**; Average prices in the Housing sector dropped by 5.5 percent compared to October 2011, mainly as a result of decreases in the prices of Water supply & misc. services related to dwellings (-27.0%) and Maintenance & repair of dwellings (-2.8%).

2. **Clothing & footwear**; In October 2012, prices of Clothing & footwear fell with 11.3 percent compared to October 2011, mainly as a result of decreases in the average prices of Clothing (-11.6%) and Footwear (-8.7%).

3. **Household operation**; Average prices in the Household operation sector declined by 5.2 percent in October 2012. Lower prices were recorded for Furniture, furnishings, carpets & other floor coverings (-17.6%), Household appliances (-9.0%), Household textiles (-14.1%), Glassware, tableware & household utensils (-17.0%) and Tools & equipment for house & garden (-7.7%).

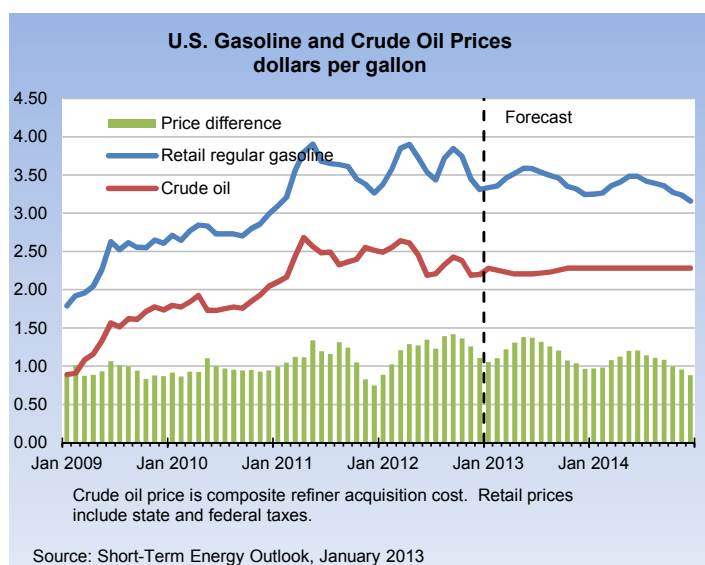

Key points

The average WTI crude oil price fell with \$5.02 per barrel in October 2012, compared to the previous month, reaching \$89.49 per barrel. The Brent (Europe) crude oil reached \$111.71 per barrel in October 2012, down from \$112.86 per barrel recorded in September 2012.

The EIA expects that the Brent crude oil spot price to drop from an average of \$112 per barrel in 2012, to an annual average of \$105 per barrel and \$99 per barrel in 2013 and 2014, respectively. The WTI crude oil price is projected to average \$90 per barrel in 2013 before increasing to an average of \$91 per barrel in 2014. Keep in mind that energy price forecasts are highly uncertain.

The U.S. monthly average regular gasoline retail prices increased from an average of \$3.53 per gallon in 2011 to average \$3.63 per gallon in 2012, despite similar crude oil prices in 2011 and 2012. The EIA expects the regular gasoline retail prices will average \$3.44 per gallon in 2013 and \$3.34 per gallon in 2014.

The on-highway diesel fuel retail prices averaged \$4.12 in September 2012, and continued tight market conditions and strong demand for exports kept on-highway diesel prices at an average of \$3.96 per gallon in December 2012.

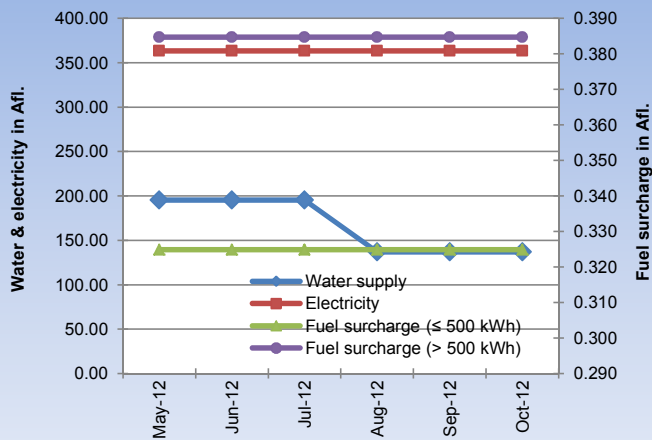

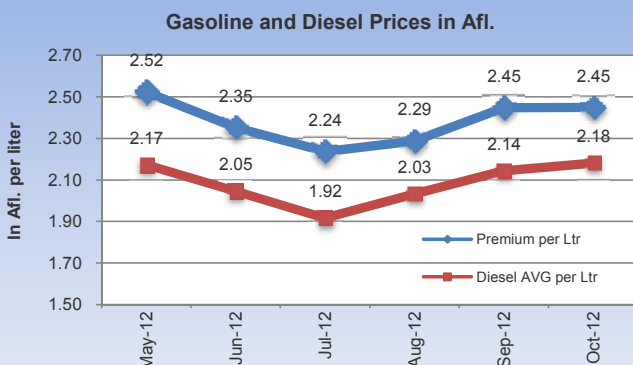

Key points

In October 2012, the price of gasoline remained unchanged when compared to the previous month. The average price of diesel rose by Afl. 0.04 per liter, reaching Afl. 2.18 per liter in October 2012. During the month of October 2012, the average prices per household of water and electricity remained at Afl. 137.05 and Afl. 363.27 respectively.

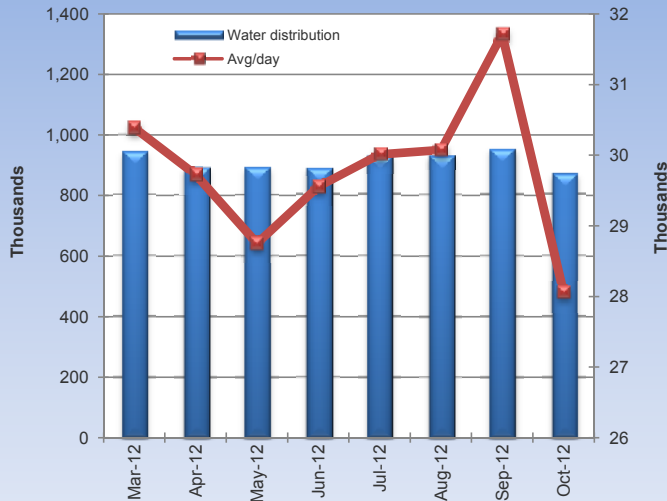

Key points

In October 2012, the average water distribution in Aruba (houses, companies, hotels, government) rose by 1.3 percent compared to October 2011. With the exception of Hotels (-4.7%), water usage increases were recorded for Houses (+2.5%), Companies (+6.5%) and Government offices (+12.9%). In the January-to-October period of 2012, the total average water distribution increased by 5.4 percent compared to the similar period of 2011.

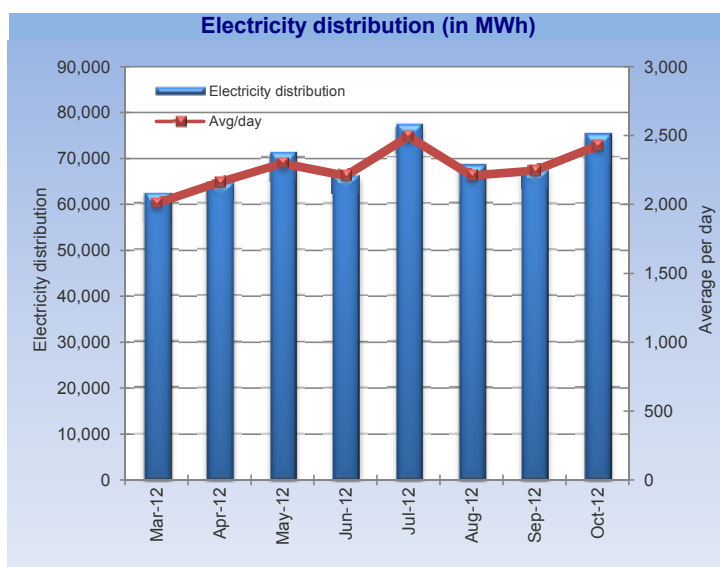

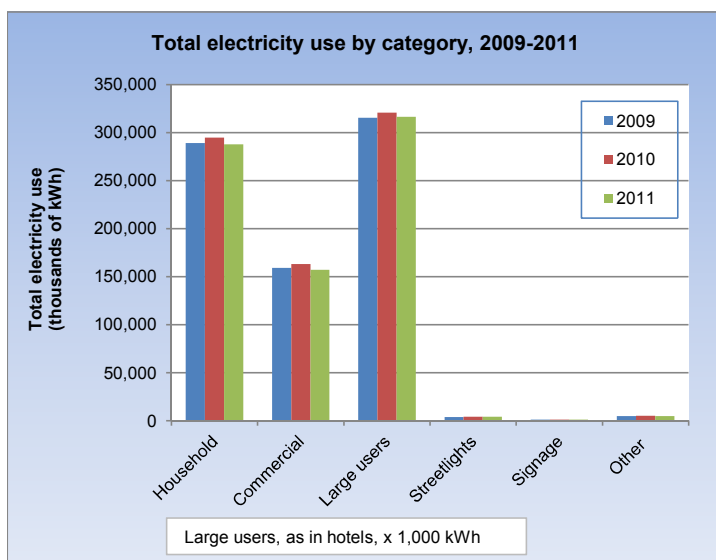

Key points

In October 2012, electricity (in MWh) supplied to Elmar for distribution increased by 5.2 percent compared to October 2011, in contrast to a drop of 1.3 percent recorded in the similar period one year earlier. In the January-to-October period of 2012, electricity distribution fell with 1.8 percent compared to the similar period of 2011.

On a year to date basis, the total electricity usage (as reported by the ELMAR N.V.) decreased by 1.2 percent in October 2012, compared to the similar period of 2011. This drop is mainly caused by decreases in the usage of electricity by Households (-3.8%), Large users (-0.8%) and streetlights (-1.0%).

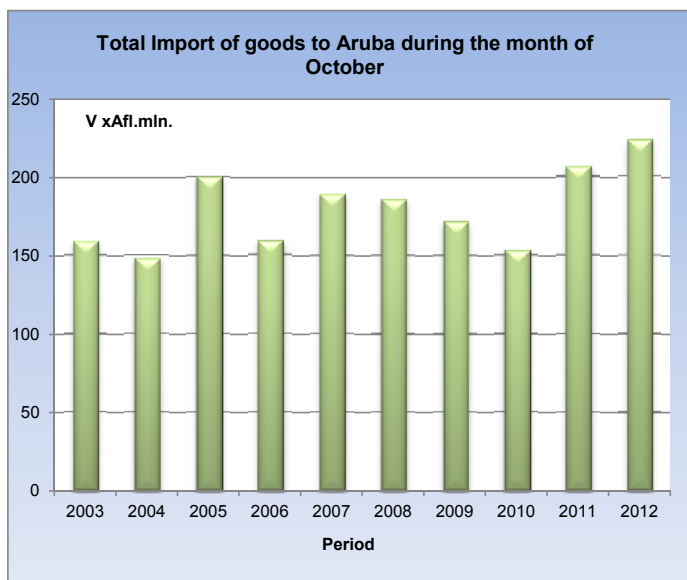

Key points

In October 2012, the total import of merchandise to Aruba rose by 8.2 percent compared to October 2011, following an increase of 34.9 percent recorded in the similar period one year earlier. With the exception of Mineral, chemical & related products (-21.9%) and Metal products, machinery & equipment (-10.3%), import increases have been recorded for Agriculture products (+45.2%), Textiles, pearls & precious stones (+23.6%) and Other transportable goods (+15.1%).

In the January-to-October period of 2012, the total import of goods to Aruba fell with 0.9 percent compared to the similar period of 2011.

Compared to October 2011, the total exports of goods from Aruba expanded by 139.1 percent in October 2012. Export increases have been recorded for all commodities, particularly, Agriculture products (+124.7%), Metal products, machinery & equipment (+296.0%), Other transportable goods (+136.3%), Textiles, pearls & precious stones (+184.4%) and Mineral, chemical & related products (+117.2%).

On a year to date basis, the total export of goods to Aruba in October 2012 increased by 32.2 percent, when compared to the similar period of 2011.

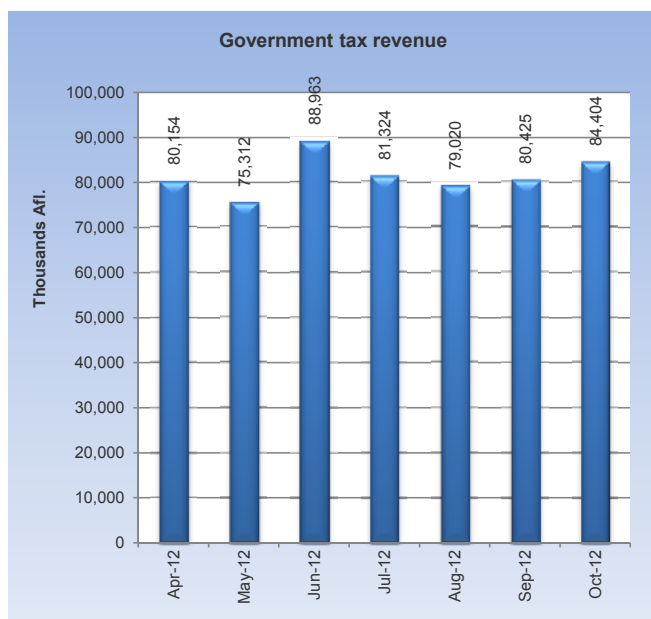

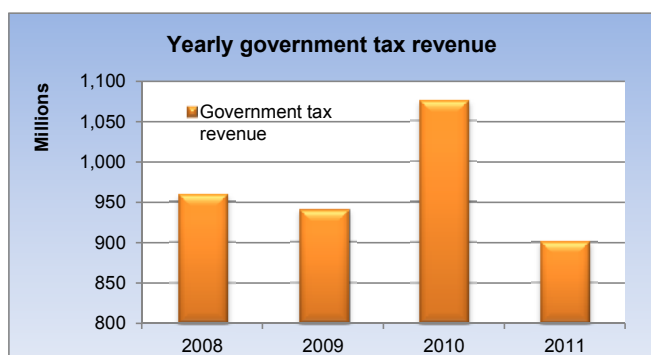

Key points

In October 2012, the total government tax revenue increased by 12.5 percent compared to October 2011, following an increase of 28.2 percent recorded in the similar period one year earlier. In the January-to-October period of 2012, the total government tax revenues rose by 8.7 percent compared to the similar period of 2011. On a year-to-date basis, the main increases were recorded for the Profit tax (+35.5%), Land tax (+60.2%), Succession tax (+3,253.0%), Dividend tax (+77.2%), Import duties (+2.5%) and the Turnover tax (+3.9%).

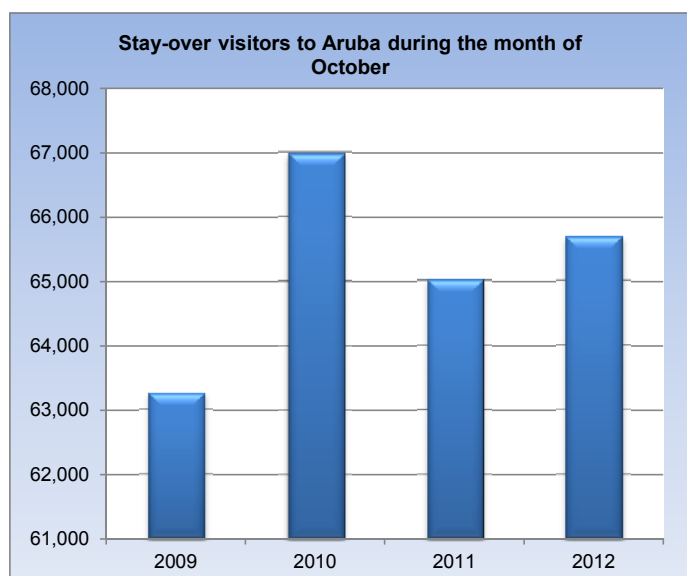

Key points

In October 2012, the total number of stay-over visitors to Aruba increased by 1.0 percent compared to October 2011, in contrast to a drop of 2.9 percent recorded during the similar period one year earlier. The main increases were recorded for the visitors from Venezuela (+20.3%), Canada (+43.5%), Colombia (+26.0%), Surinam (+67.0%) and Curacao (+6.2%).

In the January-to-October period of 2012, the total number of visitors to Aruba increased by 2.7 percent compared to the similar period of 2011. This growth is led by increases in the visitors from Venezuela (+18.4%), Canada (+10.7%), Argentina (+29.1%), Netherlands Antilles (+6.8%) and Surinam (+22.6%).

The share of the US market, which is the largest market, fell from 61.9 percent in October 2011 to 59.9 percent in October 2012. The Venezuelan market, the second largest market, recorded a market share of 14.7 percent in October 2012, up from 12.8 percent recorded in October 2011.
