

Consumer Price Index, base period December 2006 July 2014

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of July 2014.

The CPI for July 2014 is 118.16, an increase of 0.5% compared to the index of June 2014 (117.63) and accumulating an increase of 1.4% up to and including July of this year.

The percentage change of the CPI over the last 12 months (July 2013 to July 2014) is 0.7, an increase of 3.5 percentage points (ppts) compared to the percentage change for the same period of last year (-2.8).

The period average percentage change of the CPI for the period July 2013 - July 2014 is -0.5, an increase of 2.6 ppts compared to the period average percentage change over the period July 2012 - July 2013 (-3.1).

During this month, nine of the twelve sectors registered increases in prices. The increases which had the greatest influence on the CPI were registered for the "Transport" (1.1%) and "Recreation and culture" (2.2%) sectors, causing an effect of 0.21 and 0.18 ppts, respectively. The increases in the remaining sectors had a total effect of 0.08 ppts on the CPI of July 2014.

Aforementioned increases were partially offset mainly by a decrease in the index for the "Food and non-alcoholic beverages" (-0.1%) sector, which had an influence of -0.01 ppt. The decrease in the remaining sector had an insignificant effect on the CPI of July 2014.

The increase in the "Transport" sector was mainly due to increases in the categories "Operation of personal transport equipment" (1.7%) and "Transport services" (2.6%), which contributed to an effect of 0.17 and 0.04 ppts, respectively. The increase in the "Recreation and culture" sector was mainly caused by an increase in the category "Recreational and cultural services" (5.5%), which contributed to an effect of 0.16 ppts.

The decrease in the "Food and non-alcoholic beverages" sector was due to a decrease of 0.3% in the category "Food", which contributed to an effect of -0.03 ppts.

The consumption basket of the CPI consists of 452 goods and services. Compared to June 2014, 37.2% of these products had an increase in price, causing an effect of 0.66 ppts, while 24.8% showed a decrease, contributing to an effect of -0.21 ppts and the remaining 38.0% had no change in price. The prices of goods increased by 0.4% and caused an influence of 0.25 ppts. The prices of services show an increase of 0.5% and had an influence of 0.20 ppts.

The CPIC (core inflation) - CPI excluding the effect of energy and food - registered in July 2014 a slight increase of 0.03%, which is 0.1 ppt higher compared to the percentage change for the same period of last year (-0.1%). The energy index - which consists of the products: electricity, water, gasoline and diesel - registered a decrease of 2.6%, which is 10.7 ppts higher compared to the percentage change for the same period of last year (-13.3%). The food index shows an increase of 0.4%, which is 0.3 ppts higher compared to the percentage change for the same period of last year (0.1%).

The subsistence level for a household consisting of two adults and two children (aged 0-14 years) in July 2014 is Afl. 4,298, while for a single adult household it is Afl. 2,047.



Change in prices of crude oil, utilities, gasoline and diesel in July 2014

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In July 2014 the average price per barrel of crude oil (US\$ 103.87) had a decrease of US\$ 1.91 (-1.8%) compared to June 2014 (US\$ 105.78).

Fuel surcharge for a usage of electricity up to 500 kWh did not change in July 2014, it stayed at Afl. 24.60 cents per kWh. Fuel surcharge for a usage of electricity between 501 - 1000 kWh did not change in July 2014, it stayed at Afl. 30.90 cents per kWh. The prices of electricity and water did not change compared to June 2014. Subsequently, the average electricity price per household remained at Afl. 306.75, while the average price of water per household remained at Afl. 137.05.

In July 2014 the price of gasoline increased by Afl. 0.06 (2.4%) causing an effect of 0.16 ppts on the CPI. The price of diesel registered an increase of Afl. 0.01 (0.4%) and had an insignificant effect on the CPI of July 2014.

In July 2014, utilities, gasoline and diesel as a group show an increase in price of 0.8% compared to June 2014, and had an influence of 0.17 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced an increase of 0.4% in price, causing an effect of 0.28 ppts on the CPI.

Change in prices of Food & catering services in July 2014

The "Food & catering services" index shows a slight decrease of 0.04% in July 2014, after an increase of 0.2% in June 2014. The index for "Food at home" shows a decrease of 0.1% in July, as six of the eleven "Food at home" indices decreased in July 2014. The "Potatoes and other tubers" index registered the largest decrease (-8.5%) in July and was mainly caused by a decrease of 11.0% in the index for "Potatoes". Furthermore, decreases of 1.7% and 1.6% were posted in the indices for "Fish and other seafood" and "Fruit", respectively. The "Non-alcoholic beverages" index registered the largest increase (1.4%), followed by increases of 0.5% and 0.3% in the indices for "Milk, cheese and eggs" and "Meat".

Over the last 12 months the "Food & catering services" index has increased by 2.1%. The "Food at home" index also shows an increase of 2.1%. The "Milk, cheese and eggs" index increased by 5.8%, the largest increase among the "Food at home" food groups, while the "Oils and fats" index shows the largest decrease (-2.9%).

The index for "Food away from home" shows a slight increase of 0.01% in July, after a slight decrease of 0.03% in June 2014 and has increased by 2.2% over the last 12 months.

In July 2014, "Food at home" and "Food away from home" as a group show decrease in price of 0.04% compared to June 2014, and had an influence of -0.01 ppt on the CPI, while the remaining goods and services, as a group, experienced an increase in price of 0.6%, causing an effect of 0.46 ppts on the CPI.
