

Foreign Trade, 2nd Quarter 2016

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 2nd quarter 2016.

Total Import to Aruba

The total import to Aruba for the second quarter of 2016, in terms of weight, increased with 10.9%, from 134.5 mln kg in 2015 to 149.1 mln kg in 2016, while, in terms of value, it decreased by 3.2% from Afl. 466.5 mln to Afl. 451.5 mln.

Import to the free circulation area of Aruba* (weight)

During this period nine (9) of the twenty-one (21) sections, in terms of weight, registered increases in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Mineral products" (14.5 mln. kg), "Food products)" (1.1 mln. kg), "Live animals and other animal products" (0.4 mln. kg) and "Transport equipment" (0.4 mln. kg).

The largest decrease is seen for the section "Various goods and products n.e.s." (-1.0 mln. kg). Furthermore, decreases of 0.4 mln. kg were registered for the sections "Base metals and derivated works" and "Works of stone, gypsum, cement, asbestos".

Import to the free circulation area of Aruba (value)

Thirteen (13) of the twenty-one (21) sections, in terms of value, registered decreases in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Mineral products)" (Afl. -6.0 mln), "Various goods and products n.e.s." (Afl. -4.4 mln.) and "Machinery & electrotechnical equipment (new & renewed)" (Afl. -3.1 mln).

The largest increase is seen for the section "Food products" (Afl. 5.4 mln). Furthermore, increases of Afl. 2.7 mln and Afl. 1.7 mln were registered for the "Transport equipment" and "Live animals and other animal products" sections, respectively.

Import to the free circulation area of Aruba by sea

Import by sea to the free circulation area of Aruba, in terms of *weight*, registered an increase of 11.0% in the second quarter of 2016 (148.4 mln kg) compared to the same period in 2015 (133.7 mln kg), while, in terms of *value*, it decreased by 2.5% from Afl. 379.2 mln to Afl. 369.7 mln.

Import to the free circulation area of Aruba by air

Import by air to the free circulation area of Aruba, in terms of *weight*, decreased by 4.2% from Afl. 0.78 mln in the second quarter of 2015 to Afl. 0.75 mln in the second quarter of 2016, while, in terms of *value*, it decreased by 6.3% from Afl. 87.3 mln to Afl. 81.8 mln.

Import to the free circulation area of Aruba by Large companies

Import by "Large companies", in terms of **weight**, increased by 2.2% from 24.7 mln kg in the second quarter of 2015 compared to 25.3 mln kg in the second quarter of 2016, while, in terms of **value**, it decreased by 23.2% from Afl. 50.7 mln to Afl. 38.9 mln.

Total Export

The total export, in terms of **weight**, registered an increase of 54.8% in the second quarter of 2016 (5.7 mln kg) compared to the same period of 2015 (3.7 mln kg), while, in terms of **value**, it increased by 28.4% from Afl. 35.5 mln to Afl. 45.6 mln.



Total Export from Aruba (value)

Seventeen (17) of the twenty-one (21) sections, in terms of value, registered increases in the total export from Aruba. The largest increases are observed for the sections "Real pearls (natural) and other precious stones" (Afl. 4.1 mln), "Optical instruments, apparatus and equipment" (Afl. 3.4 mln.) and "Base metals and derivated works" (Afl. 2.3 mln). The largest decrease is seen for the section "Textile fibers and articles" (Afl. -1.0 mln). Furthermore, decreases of Afl. 0.4 mln and Afl. 0.01 mln were registered for the "Transport equipment" and "Arms and ammunition" sections, respectively.
