Consumer Price Index, base period December 2006

January 2017

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of January 2017.

The CPI for January 2017 is 116.63, a decrease of 1.2% compared to the index of December 2016 (118.00).

The percentage change of the CPI over the last twelve (12) months (January 2016 to January 2017) is -0.4%, an increase of 0.1 percentage point (ppt) compared to the percentage change for the same period of last year (-0.5%).

The period average percentage change of the CPI for the period January 2016 - January 2017 is -0.9%, a decrease of 1.2 ppts compared to the period average percentage change over the period January 2015 - January 2016 (0.3%).

During this month, six (6) of the twelve (12) sectors registered decreases in prices. The decreases which had the greatest influence on the CPI were registered for the "Housing" (-4.1%) and "Recreation and culture" (-2.9%), causing an effect of -1.19 and -0.25 ppts, respectively. The decreases in the remaining sectors had an effect of -0.06 ppts on the CPI of January 2017.

Aforementioned decreases were partially offset mainly by an increase in the index for the "Transport" (1.8%) sector, which had an influence of 0.30 ppts on the CPI of January 2017. The increases in the remaining sectors had an effect of 0.04 ppts on the CPI of January 2017.

The decrease in the "Housing" sector was caused by a decrease of 13.6% in the category "Electricity, gas and other fuels", which contributed to an effect of -1.21 ppts. The decrease in the "Recreation and culture" sector was mainly due to a decrease in the category "Holidays" (-26.8%), which contributed to an effect of -0.24 ppts.

The increase in the "Transport" sector was caused by an increase of 5.1% in the category "Operation of personal transport equipment", which contributed to an effect of 0.41 ppts.

The consumption basket of the CPI consists of 452 goods and services. Compared to December 2016, 28.3% of these products had an increase in price, causing an effect of 0.70 ppts, while 29.2% showed a decrease, contributing to an effect of -1.86 ppts and the remaining 42.5% had no change in price. The prices of goods decreased by 1.3% and caused an influence of -0.83 ppts. The prices of services show a decrease of 0.9% and had an influence of -0.33 ppts on the CPI of January 2017.

The CPIC (core inflation) - CPI excluding the effect of energy and food – was 0.6% in January 2017, which is 0.7 ppts lower compared to the percentage change for the same period of last year (1.3%). The energy index - which consists of the products: electricity, water, gasoline and diesel – is -6.8%, which is 3.5 ppts lower compared to the percentage change for the same period of last year (-3.3%). The food index shows a decrease of 0.03%, which is 1.4 ppts lower compared to the percentage change for the same period of last year (1.4%).

The subsistence level for a household consisting of two (2) adults and two (2) children (aged 0-14 years) in January 2017 is Afl. 4,323, while for a single adult household it is Afl. 2,059.

Change in prices of crude oil, utilities, gasoline and diesel in January 2017

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In January 2017 the average price per barrel of crude oil (US\$ 52.49) had an increase of US\$ 1.08 (2.1%) compared to December 2016 (US\$ 51.41).

Fuel surcharge for a usage of electricity up to 500 kWh decreased by Afl. 5.88 cents per kWh from Afl. 21.90 cents per kWh in December 2016 to Afl. 16.02 cents per kWh in January 2017. Fuel surcharge for a usage of electricity between 501 - 1000 kWh decreased by Afl. 6.08 cents per kWh from Afl. 27.80 cents per kWh in December 2016 to Afl. 21.72 cents per kWh in January 2017. The the flat rate remained at Afl. 12.50. Subsequently, the average electricity price per household decreased from Afl. 308.76 to Afl. 265.65 (-14.0%) causing an effect of -1.21 ppts on the CPI, while the average price of water per household remained at Afl. 137.05. Furthermore, the Fuel surcharge for a usage of electricity more than 1000 kWh decreased by Afl. 1.71 cents per kWh from Afl. 33.64 cents per kWh in December 2016 to Afl. 31.93 cents per kWh in January 2017.

In January 2017 the price of gasoline increased by Afl. 13.60 cents (8.2%) causing an effect of 0.39 ppts on the CPI. The price of diesel registered an increase of Afl. 9.90 cents (7.1%) and had an effect 0.02 ppts on the CPI of January 2017.

In January 2017, utilities, gasoline and diesel as a group show a decrease in price of 4.4% compared to December 2016, and had an influence of -0.80 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced a decrease of 0.4% in price, causing an effect of -0.36 ppts on the CPI.

Change in prices of Food & catering services in January 2017

The "Food & catering services" index shows a slight decrease of 0.05% in January 2017, after a decrease of 0.2% in December 2016. The index for "Food at home" shows a decrease of 0.2% in January, as four (4) of the eleven (11) "Food at home" indices decreased in January 2017. The "Fruit" index registered the largest decrease (-4.3%) in January 2017. Furthermore, decreases were posted in the indices for "Milk, cheese and eggs" (-0.3%), "Oils and fats" (-0.1%) and "Non-alcoholic beverages" (-0.1%). The "Vegetables" index registered the largest increase (3.3%). Furthermore, increases of 2.6%, 0.9% and 0.7% were posted in the indices for "Potatoes and other tubers", "Food products n.e.c." and "Fish and other seafood", respectively.

Over the last twelve (12) months the "Food & catering services" has increased by 0.1%. The "Food at home" index shows a decrease of 0.2%. The "Vegetables" index decreased by 13.5%, the largest decrease among the "Food at home" food groups, while the "Fruit" index shows the largest increase (17.5%).

The index for "Food away from home" shows an increase of 0.5% in January 2017 after being unchanged in December 2016 and has increased by 1.2% over the last twelve (12) months.

In January 2017, "Food at home" and "Food away from home" as a group show a slight decrease in price of 0.05% compared to December 2016, and had an influence of -0.01 ppt on the CPI, while the remaining goods and services, as a group, experienced a decrease in price of 1.4%, causing an effect of -1.15 ppts on the CPI.
