

Consumer Price Index, base period December 2006

February 2017

The Central Bureau of Statistics presents the most important findings for the Consumer Price Index (CPI) for the month of February 2017.

The CPI for February 2017 is 116.58, a slight decrease of 0.04% compared to the index of January 2017 (116.63) and accumulating a decrease of 1.2% up to and including February of this year.

The percentage change of the CPI over the last twelve (12) months (February 2016 to February 2017) is -0.3%, an increase of 0.3 percentage points (ppts) compared to the percentage change for the same period of last year (-0.6%).

The period average percentage change of the CPI for the period February 2016 - February 2017 is -0.8%, a decrease of 1.0 ppt compared to the period average percentage change over the period February 2015 - February 2016 (0.2%).

During this month, five (5) of the twelve (12) sectors registered decreases in prices. The decreases which had the greatest influence on the CPI were registered for the "Food and non-alcoholic beverages" (-0.6%), "Recreation and culture" (-0.5%) and "Clothing and footwear" (-0.6%), causing an effect of -0.09, -0.04 and -0.03 ppts, respectively. The decreases in the remaining sectors had an effect of -0.02 ppts on the CPI of February 2017.

Aforementioned decreases were partially offset mainly by increases in the indices for the "Transport" (0.3%) and "Housing" (0.2%) sectors, which each had an influence of 0.05 ppts on the CPI of February 2017. The increases in the remaining sectors had an effect of 0.04 ppts on the CPI of February 2017.

The decrease in the "Food and non-alcoholic beverages" sector was mainly caused by a decrease of 0.7% in the category "Food", which contributed to an effect of -0.08 ppts. The decrease in the "Recreation and culture" sector was mainly due to a decrease in the category "Holidays" (-4.8%), which contributed to an effect of -0.03 ppts. The decrease in the "Clothing and footwear" sector was mainly due to a decrease in the category "Clothing" (-0.5%), which contributed to an effect of -0.02 ppts.

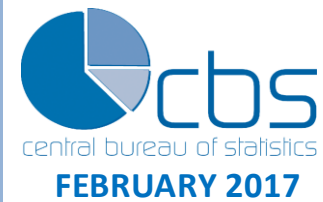
The increase in the "Transport" sector was due to increases in the categories "Operation of personal transport equipment" (0.3%) and "Transport services" (1.6%), which contributed to an effect of 0.03 and 0.02 ppts. The increase in the "Housing" sector was mainly caused by an increase of 0.8% in the category "Maintenance and repair of the dwelling", which contributed to an effect of 0.03 ppts.

The consumption basket of the CPI consists of 452 goods and services. Compared to January 2017, 31.2% of these products had an increase in price, causing an effect of 0.34 ppts, while 29.9% showed a decrease, contributing to an effect of -0.39 ppts and the remaining 38.9% had no change in price. The prices of goods decreased by 0.1% and caused an influence of -0.06 ppts. The prices of services show an increase of 0.05% and had an influence of 0.02 ppts on the CPI of February 2017.

The CPIC (core inflation) - CPI excluding the effect of energy and food - was 0.6% in February 2017, which is 0.6 ppts lower compared to the percentage change for the same period of last year (1.2%). The energy index - which consists of the products: electricity, water, gasoline and diesel - is -6.5%, which is 3.0 ppts lower compared to the percentage change for the same period of last year (-3.5%). The food index shows an increase of 0.1%, which is 0.7 ppts lower compared to the percentage change for the same period of last year (0.8%).

The subsistence level for a household consisting of two (2) adults and two (2) children (aged 0-14 years) in February 2017 is Afl. 4,314, while for a single adult household it is Afl. 2,054.

Change in prices of crude oil, utilities, gasoline and diesel in February 2017

The prices of utilities (electricity and water), gasoline and diesel are for the greater part determined by international crude oil prices. In February 2017 the average price per barrel of crude oil (US\$ 53.37) had an increase of US\$ 0.88 (1.7%) compared to January 2017 (US\$ 52.49).

Fuel surcharge for a usage of electricity up to 500 kWh did not change in February 2017, it stayed at Afl. 16.02 cents per kWh. Fuel surcharge for a usage of electricity between 501 - 1000 kWh did not change in February 2017, it stayed at Afl. 21.72 cents per kWh. The prices of electricity and water did not change compared to January 2017. Subsequently, the average electricity price per household remained at Afl. 265.65, while the average price of water per household remained at Afl. 137.05.

In February 2017 the price of gasoline increased by Afl. 1.00 cents (0.6%) causing an effect of 0.03 ppts on the CPI. The price of diesel registered a decrease of Afl. 1.20 cents (-0.8%) and had an insignificant effect on the CPI of February 2017.

In February 2017, utilities, gasoline and diesel as a group show an increase in price of 0.2% compared to January 2017, and had an influence of 0.03 ppts on the CPI, while the remaining 448 goods and services, as a group, experienced a decrease of 0.1% in price, causing an effect of -0.07 ppts on the CPI.

Change in prices of Food & catering services in February 2017

The “Food & catering services” index shows a decrease of 0.4% in February 2017, after a slight decrease of 0.05% in January 2017. The index for “Food at home” shows a decrease of 0.6% in February, as six (6) of the eleven (11) “Food at home” indices decreased in February 2017. The “Fruit” index registered the largest decrease (-5.2%) in February 2017. Furthermore, decreases were posted in the indices for “Fish and other seafood” (-1.3%), “Sugar, jam, honey and other confectionery” (-0.9%) and “Vegetables” (-0.2%). The “Potatoes and other tubers” index registered the largest increase (2.5%). Furthermore, increases of 0.9%, 0.3% and 0.3% were posted in the indices for “Oils and fats”, “Meat” and “Food products n.e.c.”, respectively.

Over the last twelve (12) months the “Food & catering services” has increased by 0.5%. The “Food at home” index shows an increase of 0.1%. The “Fruit” index increased by 9.2%, the largest increase among the “Food at home” food groups, while the “Vegetables” index shows the largest decrease (-3.3%).

The index for “Food away from home” shows an increase of 0.3% in February 2017 after an increase of 0.5% in January 2017 and has increased by 1.5% over the last twelve (12) months.

In February 2017, “Food at home” and “Food away from home” as a group show a decrease in price of 0.4% compared to January 2017, and had an influence of -0.07 pts on the CPI, while the remaining goods and services, as a group, experienced an increase in price of 0.04%, causing an effect of 0.03 pts on the CPI.
