

Foreign Trade, 4th Quarter 2017

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 4th quarter 2017.

Total Import

The total import, in terms of **weight**, registered an increase of 5.5% in the fourth quarter of 2017 (175.8 mln kg) compared to the same period in 2016 (166.6 mln kg), while, in terms of **value**, the total import increased by 5.9%, from Afl. 587.6 mln to Afl. 622.5 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered an increase of 6.0% in the fourth quarter of 2017 (174.1 mln kg), compared to the same period in 2016 (164.3 mln kg). During this period eight (8) of the twenty-one (21) sections, registered increases in terms of weight in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Mineral products" (11.3 mln. kg), "Vegetable products" (0.7 mln. kg) and "Live animals and other animal products" (0.6 mln. kg).

The largest decrease is seen for the section "Chemical products" (-1.4 mln. kg). Furthermore, decreases of Afl. 0.5 mln and Afl. 0.4 mln were registered for the "Wood, charcoal and woodwork" and "Base metals and derivated works" sections.

Import to the free circulation area of Aruba (value)

Import to the free circulation area of Aruba, in terms of value, registered an increase of 7.3% in the fourth quarter of 2017 (Afl. 602.6 mln) compared to the same period in 2016 (Afl. 561.8 mln). Sixteen (16) of the twenty-one (21) sections, registered increases in terms of value in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Optical instruments, apparatus and equipment" (Afl. 5.0 mln), "Live animals and other animal products" (Afl. 4.9 mln.) and "Food products" (Afl. 4.6 mln).

The largest decrease is seen for the section "Base metals and derivated works" (Afl. -1.2 mln). Furthermore, decreases were registered for the "Miscellaneous manufactured articles" (Afl. -1.1 mln), "Fats and oils" (Afl. -0.4 mln) and "Wood, charcoal and woodwork" (Afl. -0.4 mln) sections.

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba by Sea

Import by Sea to the free circulation area of Aruba, in terms of **weight**, registered an increase of 6.1% in the fourth quarter of 2017 (173.3 mln kg) compared to the same period in 2016 (163.4 mln kg), while, in terms of **value**, the import by Sea increased by 8.5% from Afl. 443.4 mln to Afl. 481.1 mln.

2. Import to the free circulation area of Aruba by Air

Import by Air to the free circulation area of Aruba, in terms of **weight**, decreased by 18.8% from 0.88 mln kg in the fourth quarter of 2016 to 0.71 mln kg in the fourth quarter of 2017, while, in terms of **value**, the import by Air increased by 2.6% from Afl. 118.4 mln to Afl. 121.5 mln.

Import to the free circulation area of Aruba by Large companies**

Import by "Large companies", in terms of **weight**, decreased by 4.9% from 26.1 mln kg in the fourth quarter of 2016 compared to 24.8 mln kg in the fourth quarter of 2017, while, in terms of **value**, it increased by 6.7% from Afl. 46.3 mln to Afl. 49.4 mln.

Total Export

The total export, in terms of **weight**, registered a decrease of 4.2% in the fourth quarter of 2017 (6.2 mln kg) compared to the same period of 2016 (6.5 mln kg), while, in terms of **value**, the total export decreased by 11.8% from Afl. 48.8 mln to Afl. 43.1 mln.

Export from the free circulation area of Aruba (weight)

Export from the free circulation area of Aruba, in terms of weight, registered an increase of 12.5% in the fourth quarter of 2017 (4.2 mln kg) compared to the same period in 2016 (3.8 mln kg). Fourteen (14) of the twenty-one (21) sections, registered increases in terms of weight in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Base metals and derivated works" (0.7 mln. kg) and "Materials for the manufacture of paper, paperwork" (0.5 mln. kg).

The largest decreases are observed for the sections "Vegetable products" (-0.7 mln kg), "Fats and oils" (-0.1 mln kg) and "Food products" (-0.1 mln kg).

Export from the free circulation area of Aruba (value)

Export from the free circulation area of Aruba, in terms of value, registered a decrease of 1.2% in the fourth quarter of 2017 (Afl. 19.0) compared to the same period in 2016 (Afl. 19.2). Eleven (11) of the twenty-one (21) sections, registered decreases in terms of value in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Live animals and other animal products" (Afl. -1.1 mln), "Vegetable products" (Afl. -0.7 mln), "Footwear, headgear and umbrellas" (Afl. -0.4 mln) and "Machinery & electrotechnical equipment (new & renewed)" (Afl. -0.4 mln).

The largest increases are observed for the sections "Chemical products" (Afl. 0.9 mln), "Food products" (Afl. 0.6 mln) and "Real pearls (natural) and other precious stones" (Afl. 0.6 mln).



