

Foreign Trade, 2nd Quarter 2018

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 2nd quarter 2018.

Total Import

The total import, in terms of **weight**, registered a decrease of 2.5% in the second quarter of 2018 (147.7 mln kg) compared to the same period in 2017 (151.5 mln kg), while, in terms of **value**, the total import increased by 8.3%, from Afl. 500.5 mln to Afl. 542.2 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered a decrease of 1.9% in the second quarter of 2018 (147.0 mln kg), compared to the same period in 2017 (149.8 mln kg). During this period nine (9) of the twenty-one (21) sections, registered decreases in terms of weight in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Mineral products" (-3.6 mln. kg), "Works of stone, gypsum, cement, asbestos" (-0.7 mln. kg) and "Wood, charcoal and woodwork" (-0.3 mln. kg).

The largest increase is seen for the section "Food products" (0.4 mln. kg). Furthermore, increases of Afl. 0.3 mln kg and Afl. 0.2 mln kg were registered for the "Miscellaneous manufactured articles", and "Transport equipment" sections, respectively.

Import to the free circulation area of Aruba* (value)

Import to the free circulation area of Aruba, in terms of value, registered an increase of 9.9% in the second quarter of 2018 (Afl. 528.5 mln) compared to the same period in 2017 (Afl. 480.8 mln). Eighteen (18) of the twenty-one (21) sections, registered increases in terms of value in import to the free circulation area of Aruba.

The largest increases are observed for the sections "Food products" (Afl. 8.2 mln), "Machinery & electrotechnical equipment (new & renewed)" (Afl. 6.4 mln.), "Chemical products" (Afl. 5.4 mln.) and "Optical instruments, apparatus and equipment" (Afl. 5.3 mln).

The largest decrease is seen for the section "Mineral products" (Afl. -0.8 mln). Furthermore, decreases were registered for the "Fats and oils" (Afl. -0.1 mln) and "Wood, charcoal and woodwork" (Afl. -0.03 mln) sections.

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba* by Sea

Import by Sea to the free circulation area of Aruba, in terms of **weight**, registered a decrease of 2.1% in the second quarter of 2018 (146.0 mln kg) compared to the same period in 2018 (149.2 mln kg), while, in terms of **value**, the import by Sea increased by 9.6% from Afl. 396.1 mln to Afl. 434.1 mln.

2. Import to the free circulation area of Aruba* by Air

Import by Air to the free circulation area of Aruba, in terms of **weight**, increased by 54.0% from 0.7 mln kg in the second quarter of 2017 to 1.0 mln kg in the second quarter of 2018, while, in terms of **value**, the import by Air increased by 11.5% from Afl. 84.6 mln to Afl. 94.4 mln.

Import to the free circulation area of Aruba* by Large companies**

Import by "Large companies", in terms of **weight**, increased by 12.7% from 23.1 mln kg in the second quarter of 2017 compared to 26.0 mln kg in the second quarter of 2018, while, in terms of **value**, it increased by 26.4% from Afl. 47.9 mln to Afl. 60.6 mln.

Total Export

The total export, in terms of **weight**, registered a decrease of 14.8% in the second quarter of 2018 (4.8 mln kg) compared to the same period of 2017 (5.7 mln kg), while, in terms of **value**, the total export decreased by 28.6% from Afl. 29.4 mln to Afl. 41.2 mln.

Export from the free circulation area of Aruba* (weight)

Export from the free circulation area of Aruba, in terms of weight, registered an increase of 0.8% in the second quarter of 2018 (4.1 mln kg) compared to the same period in 2017 (4.0 mln kg). Seven (7) of the twenty-one (21) sections, registered increases in terms of weight in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Base metals and derivated works" (0.5 mln. kg) and "Transport equipment" (0.04 mln. kg). The largest decreases are observed for the sections "Food products" (-0.2 mln kg) and "Vegetable products" (-0.12 mln kg).

Export from the free circulation area of Aruba* (value)

Export from the free circulation area of Aruba, in terms of value, registered a decrease of 33.1% in the second quarter of 2018 (Afl. 16.6) compared to the same period in 2017 (Afl. 24.8). Fourteen (14) of the twenty-one (21) sections, registered decreases in terms of value in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Real pearls (natural) and other precious stones" (Afl. -3.4 mln), "Base metals and derivated works" (Afl. -2.9 mln) and "Optical instruments, apparatus and equipment" (Afl. -1.7 mln). The largest increases are observed for the sections "Works of art, collectors pieces and antiques" (Afl. 1.2 mln), "Machinery & electrotechnical equipment (new & renewed)" (Afl. 0.6 mln), "Transport equipment" (Afl. 0.3 mln) and "Miscellaneous manufactured articles" (Afl. 0.3 mln).

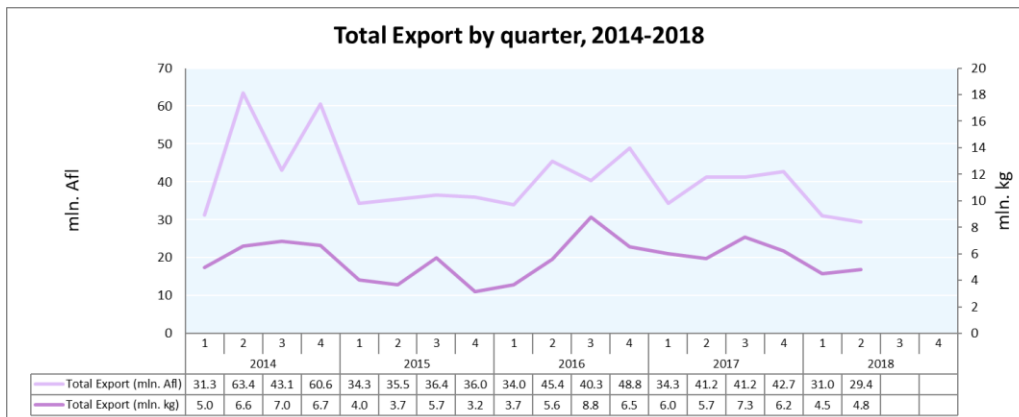
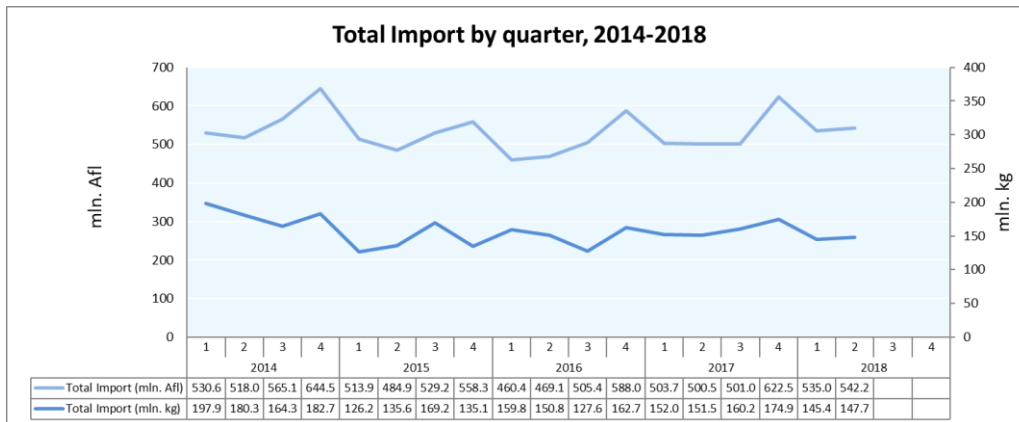
