

Foreign Trade, Fourth Quarter 2018

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 4th quarter 2018.

Total Import

The total import, in terms of **weight**, registered a decrease of 15.6% in the fourth quarter of 2018 (147.6 mln kg) compared to the same period in 2017 (174.9 mln kg), **while**, in terms of **value**, the total import decreased by 4.3%, from Afl. 626.5 mln to Afl. 599.7 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered a decrease of 15.5% in the fourth quarter of 2018 (146.4 mln kg), compared to the same period in 2017 (173.2 mln kg). During this period sixteen (16) of the twenty-one (21) sections registered decreases in terms of weight in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Mineral products" (-22.7 mln. kg), "Food products" (-1.6 mln. kg) and "Live animals and other animal products" (-1.6 mln. kg).

The largest increase is seen for the section "Works of stone, gypsum, cement, asbestos" (1.8 mln. kg). Furthermore, increases of Afl. 0.6 mln kg and Afl. 0.5 mln kg were registered for the "Wood, charcoal and woodwork", and "Miscellaneous manufactured articles" sections, respectively.

Import to the free circulation area of Aruba* (value)

Import to the free circulation area of Aruba, in terms of value, registered a decrease of 3.8% in the fourth quarter of 2018 (Afl. 583.4 mln) compared to the same period in 2017 (Afl. 606.6 mln). Thirteen (13) of the twenty-one (21) sections, registered decreases in terms of value in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Live animals and other animal products" (Afl. -10.8 mln), "Chemical products" (Afl. -6.0 mln.), "Optical instruments, apparatus and equipment" (Afl. -4.8 mln) and "Machinery & electrotechnical equipment (new & renewed)" (Afl. -4.3 mln).

The largest increase is seen for the section "Miscellaneous manufactured articles" (Afl. 7.1 mln). Furthermore, increases were registered for the "Works of stone, gypsum, cement, asbestos" (Afl. 2.3 mln) and "Real pearls (natural) and other precious stones" (Afl. 1.3 mln) sections.

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba* by Sea

Import by Sea to the free circulation area of Aruba, in terms of weight, registered a decrease of 15.7% in the fourth quarter of 2018 (145.4 mln kg) compared to the same period in 2017 (172.5 mln kg), **while**, in terms of value, the import by Sea decreased by 4.5% from Afl. 485.1 mln to Afl. 463.5 mln.

2. Import to the free circulation area of Aruba* by Air

Import by Air to the free circulation area of Aruba, in terms of weight, increased by 43.4% from 0.71 mln kg in the fourth quarter of 2017 to 1.02 mln kg in the fourth quarter of 2018, while, in terms of value, the import by Air decreased by 1.3% from Afl. 121.5 mln to Afl. 119.9 mln.

Import to the free circulation area of Aruba* by Large companies**

Import by "Large companies", in terms of weight, decreased by 1.0% from 24.8 mln kg in the fourth quarter of 2017 to 24.5 mln kg in the fourth quarter of 2018, while, in terms of value, it decreased by 1.0% from Afl. 53.3 mln to Afl. 52.8 mln.

Total Export

The total export, in terms of **weight**, registered a decrease of 12.6% in the fourth quarter of 2018 (5.4 mln kg) compared to the same period of 2017 (6.2 mln kg), while, in terms of **value**, the total export decreased by 19.5% from Afl. 42.7 mln to Afl. 34.4 mln.

Export from the free circulation area of Aruba* (weight)

Export from the free circulation area of Aruba, in terms of weight, registered an increase of 8.2% in the fourth quarter of 2018 (4.5 mln kg) compared to the same period in 2017 (4.2 mln kg). Nine (9) of the twenty-one (21) sections, registered increases in terms of weight in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Base metals and derivated works" (0.4 mln. kg), "Wood, charcoal and woodwork" (0.1 mln. kg) and "Materials for the manufacture of paper, paperwork" (0.1 mln. kg).

The largest decreases are observed for the sections "Machinery & electrotechnical equipment (new & renewed)" (-0.1 mln kg) and "Artificial plastic elements" (-0.1 mln kg).

Export from the free circulation area of Aruba* (value)

Export from the free circulation area of Aruba, in terms of value, registered a decrease of 6.8% in the fourth quarter of 2018 (Afl. 17.2) compared to the same period in 2017 (Afl. 18.5). Fourteen (14) of the twenty-one (21) sections, registered decreases in terms of value in the export from the free circulation area of Aruba. The largest decreases are observed for the sections "Chemical products" (Afl. -0.9 mln), "Machinery & electrotechnical equipment (new & renewed)" (Afl. -0.7 mln) and "Base metals and derivated works" (Afl. -0.4 mln).

The largest increases are observed for the sections "Real pearls (natural) and other precious stones" (Afl. 0.8 mln), "Machinery & electrotechnical equipment (new & renewed)" (Afl. 0.6 mln), "Base metals and derivated works" (Afl. 0.5 mln).


