Foreign Trade Statistics, Month in review

The Central Bureau of Statistics hereby presents the most important preliminary findings regarding Foreign Trade for the month February of 2022. This review will focus only on the monetary value* of the imported and exported goods.

** The free circulation area of Aruba: The economic territory of Aruba, excluding the Free Zone.

The last 12 months change is calculated by comparing the latest month with the same month one year ago.

The last 24 months change is calculated by comparing the average for the most recent 12-month period compared with the average of the preceding 12-month period.

The symbol - is used to indicate that a formula attempted to divide a value by zero.

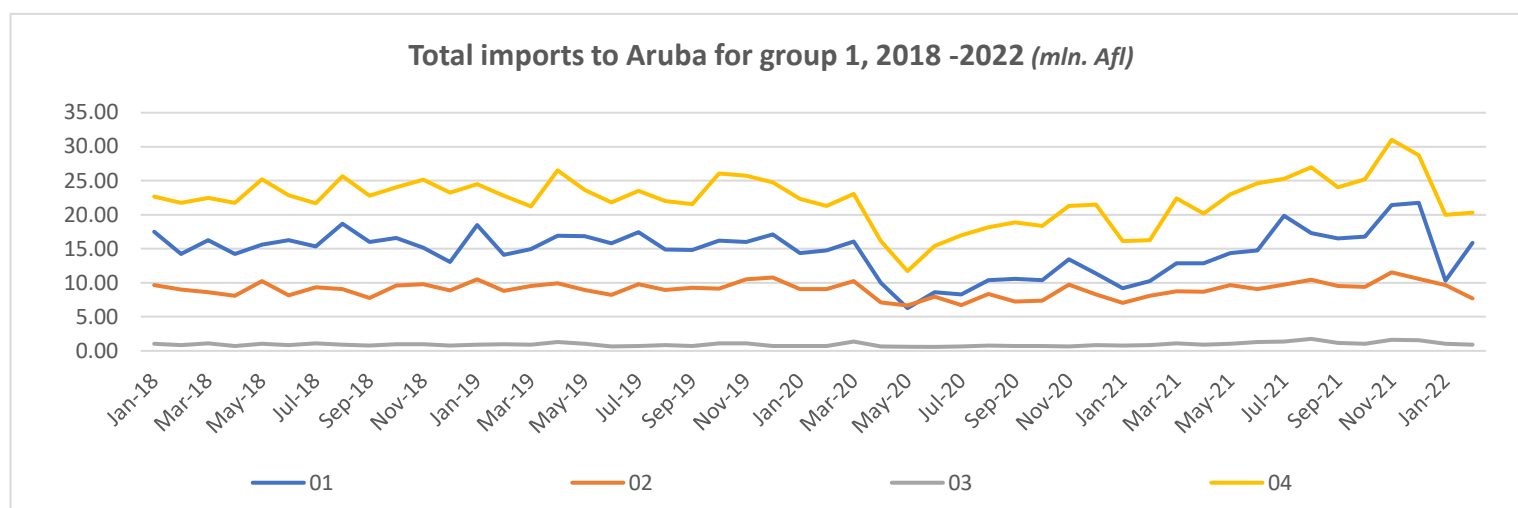

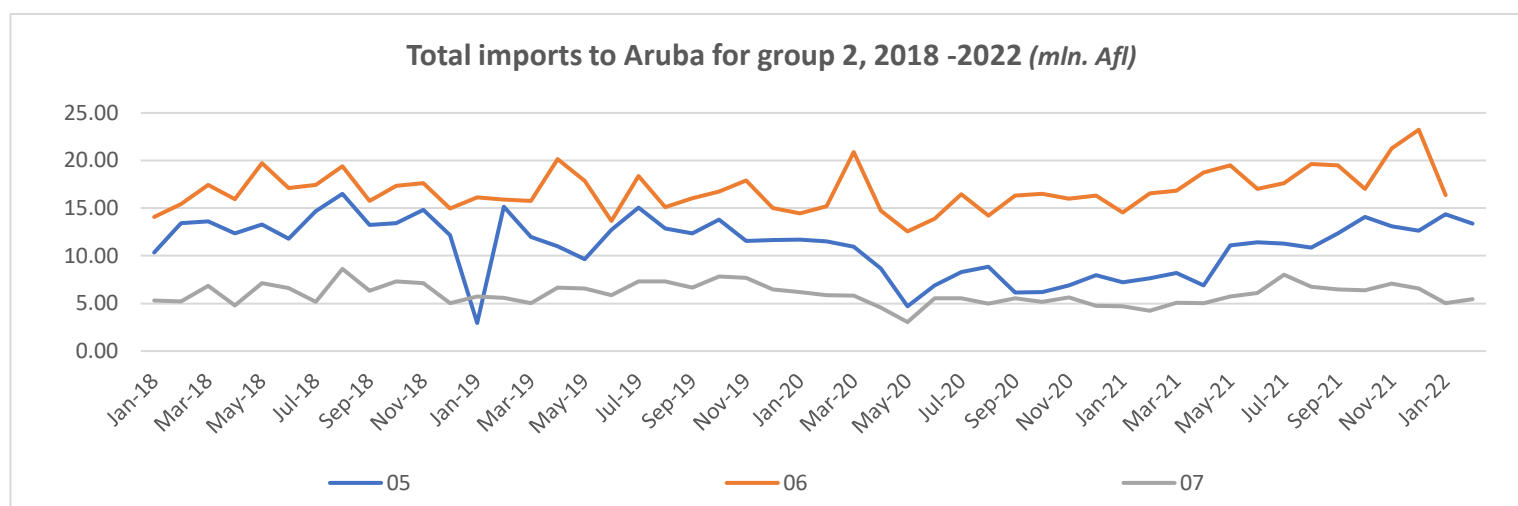

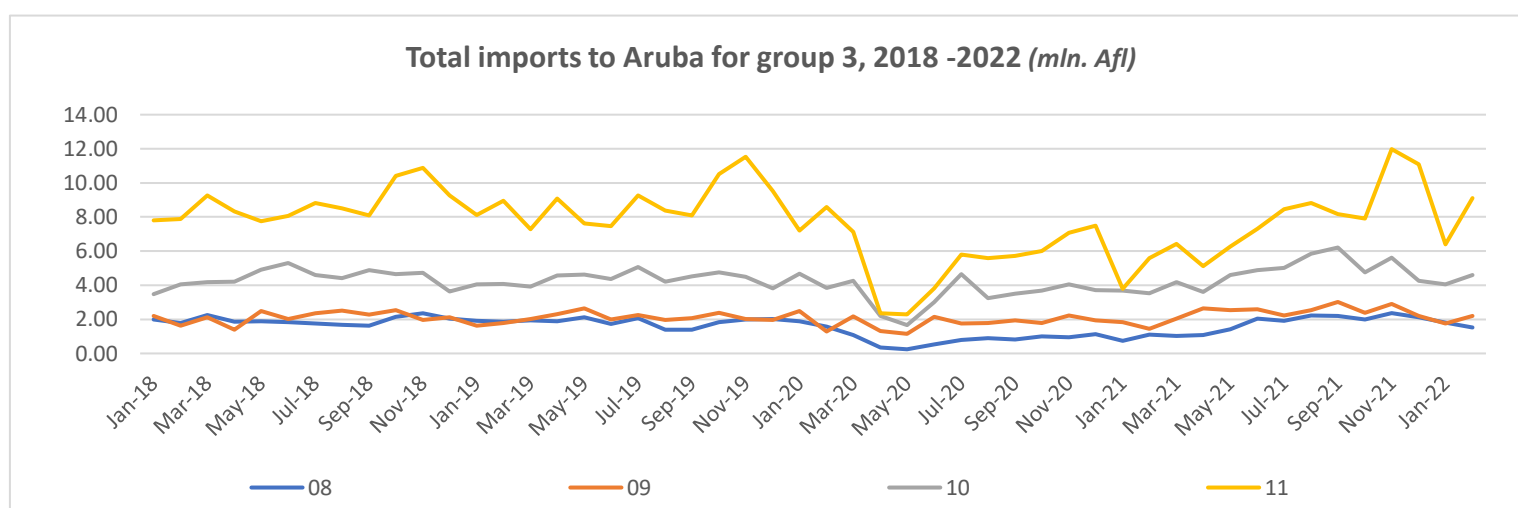
TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

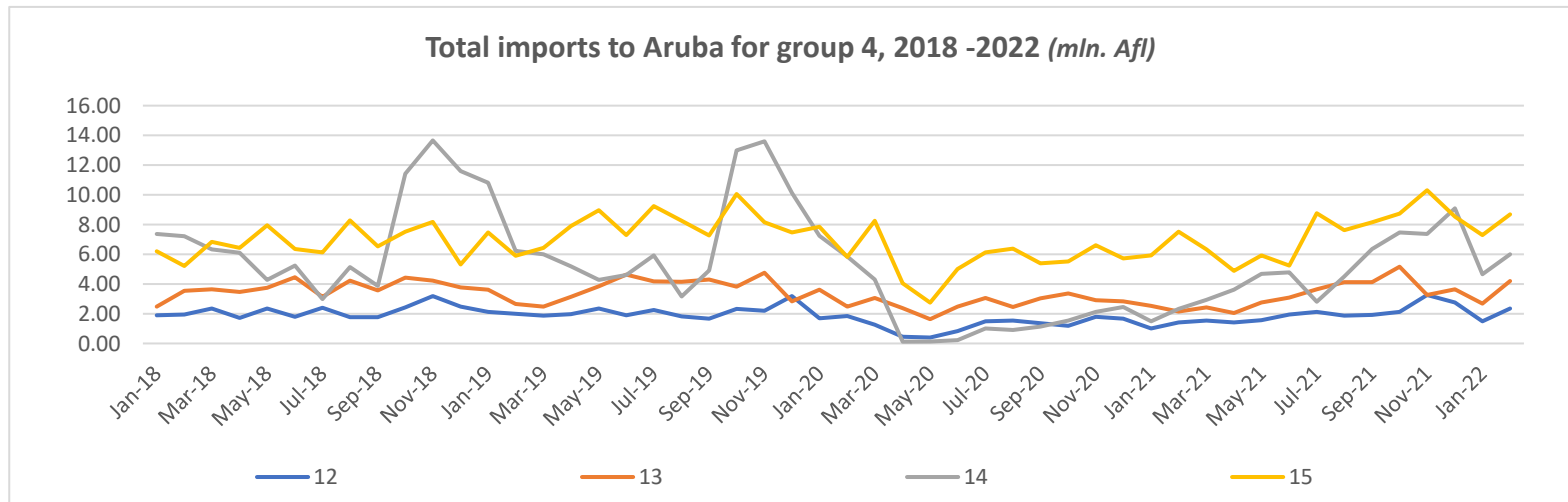

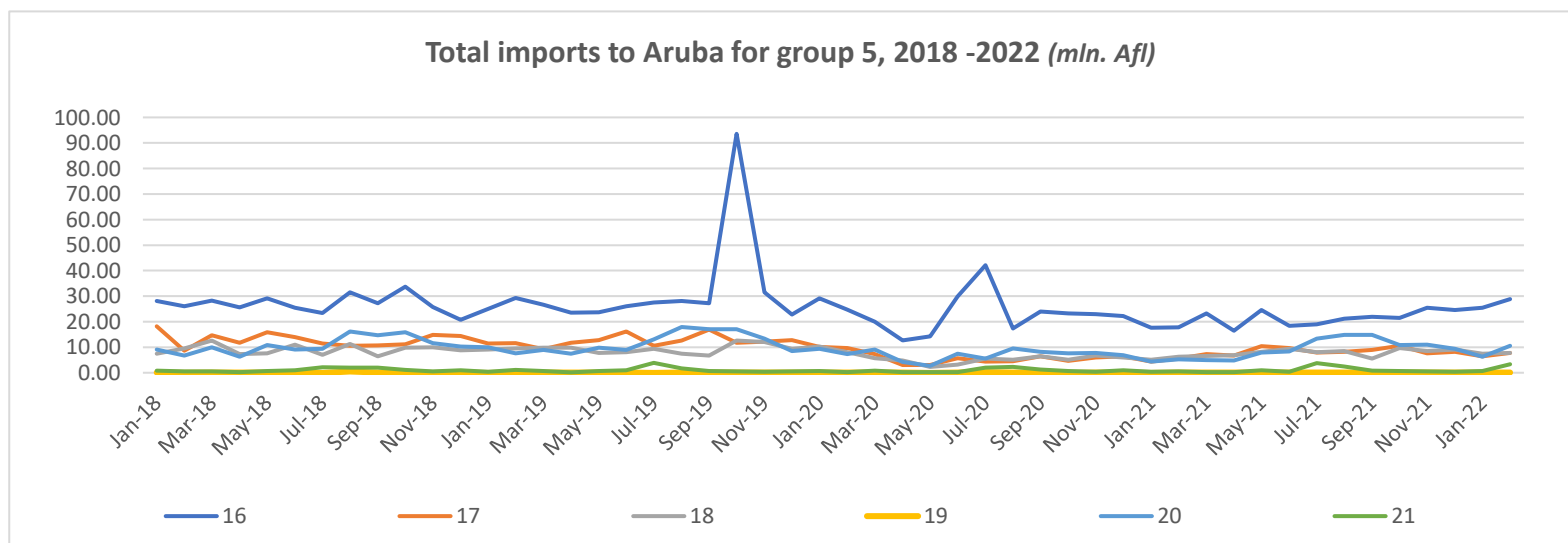

TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022



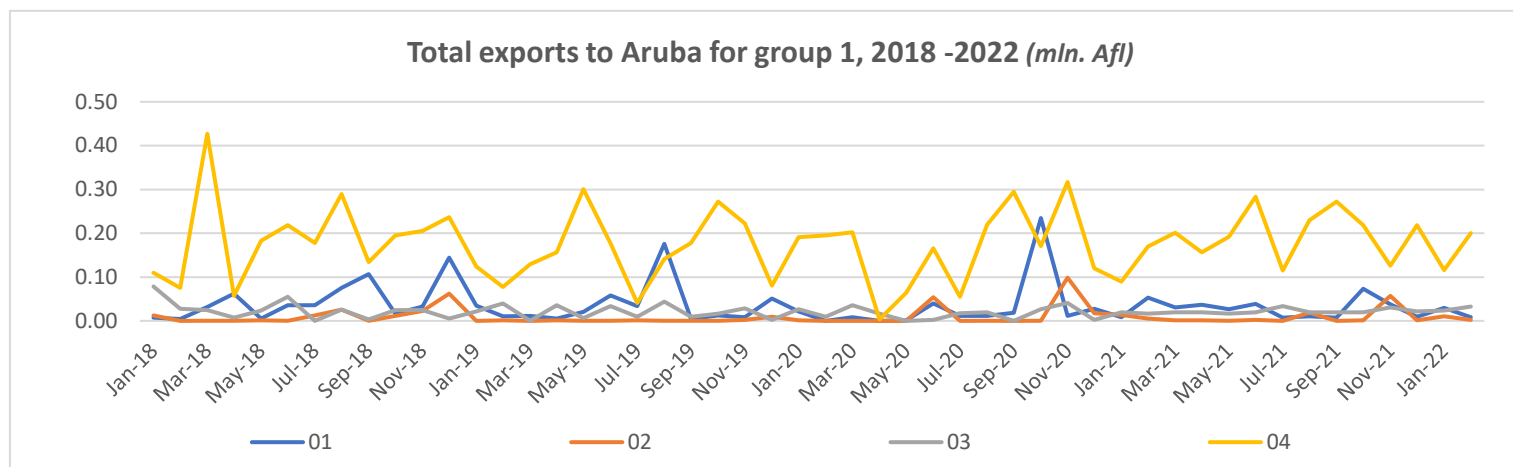

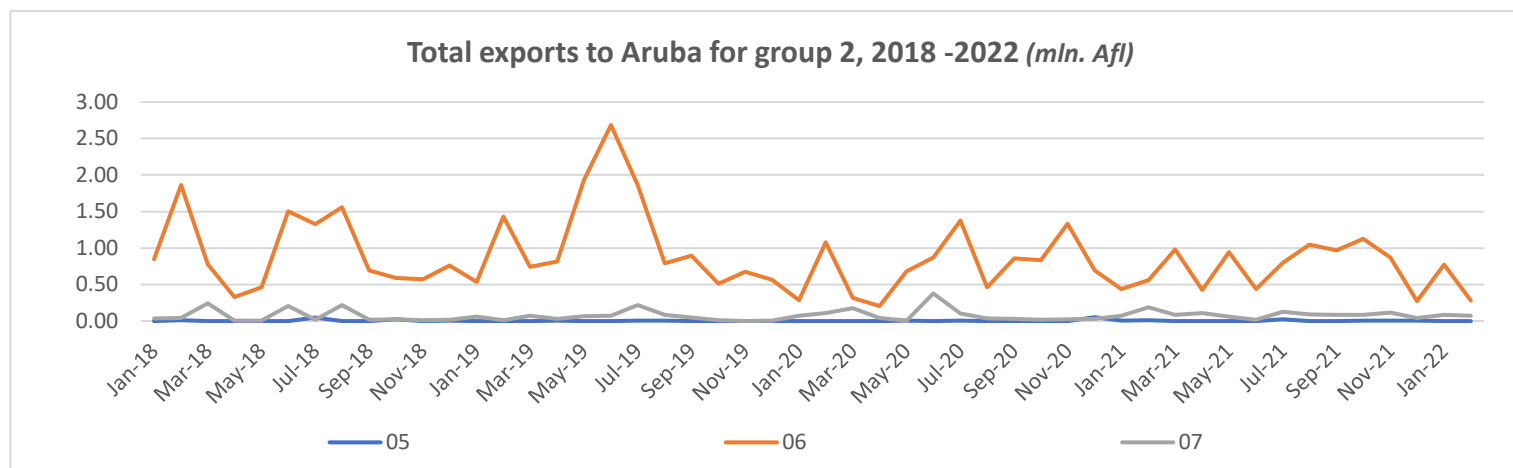

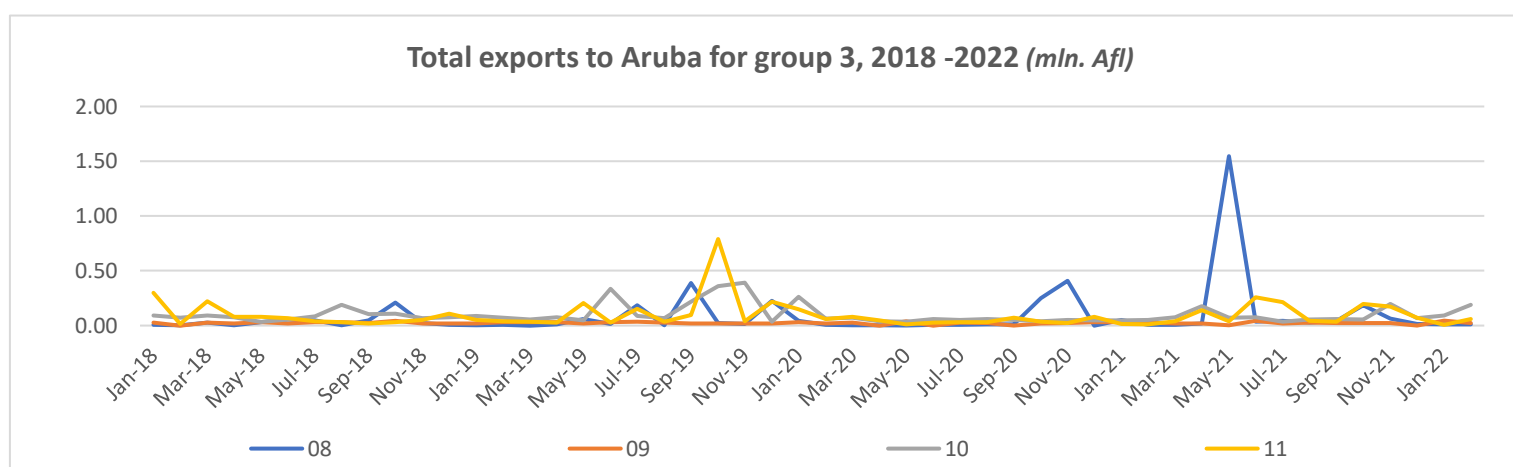
TOTAL EXPORTS FROM THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

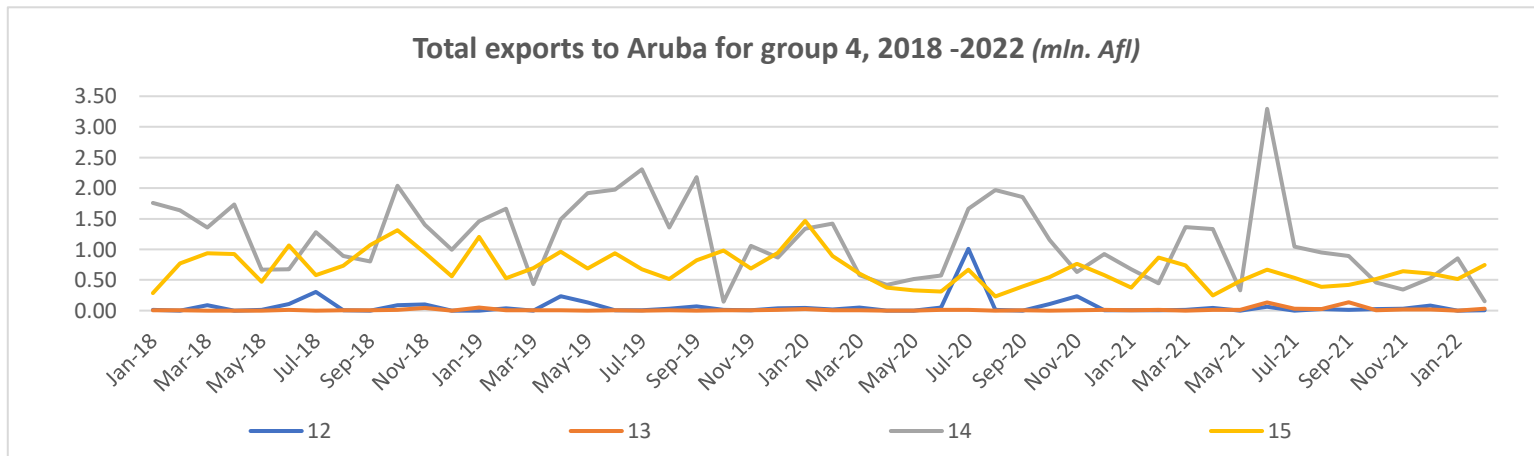

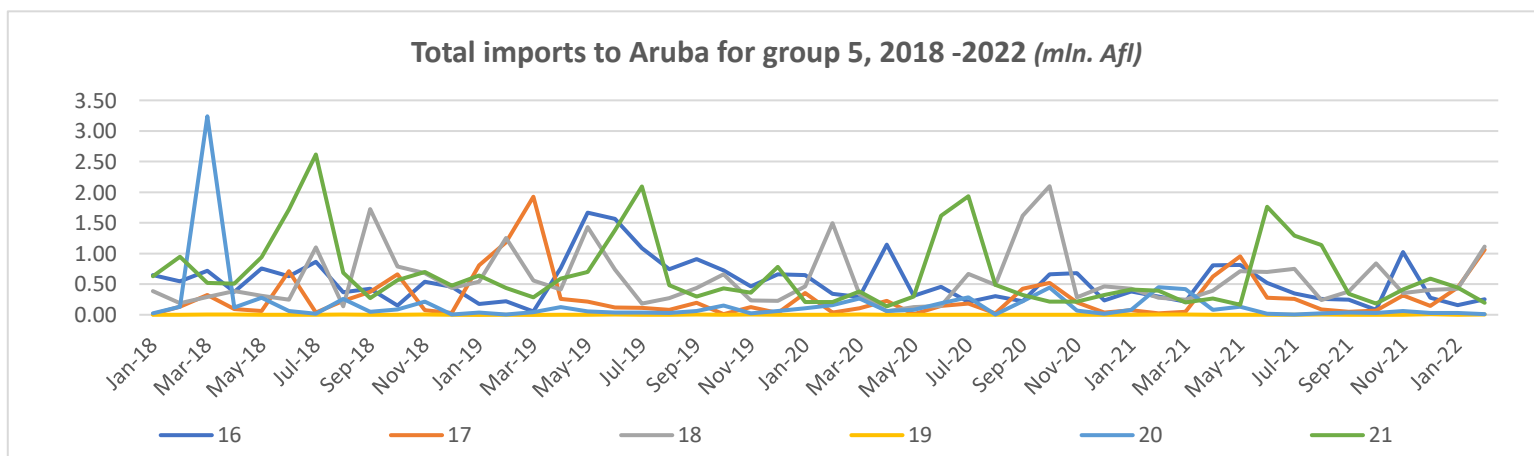
