## Foreign Trade Statistics, Month in review

The Central Bureau of Statistics hereby presents the most important preliminary findings regarding Foreign Trade for the month March of 2022. This review will focus only on the monetary value\* of the imported and exported goods.

The following findings are presented in this monthly review:

\* Monetary value of the imported and exported goods:

- The imported goods are valued (using the cost, insurance and freight valuation type (CIF)) at the border of the importing country.
- The exported goods are valued (using the free on board valuation type (FOB)) at the border of the exporting country.

\*\* The free circulation area of Aruba: The economic territory of Aruba, excluding the Free Zone.

The last 12 months change is calculated by comparing the latest month with the same month one year ago.

The last 24 months change is calculated by comparing the average for the most recent 12-month period compared with the average of the preceding 12-month period.

The symbol - is used to indicate that a formula attempted to divide a value by zero.

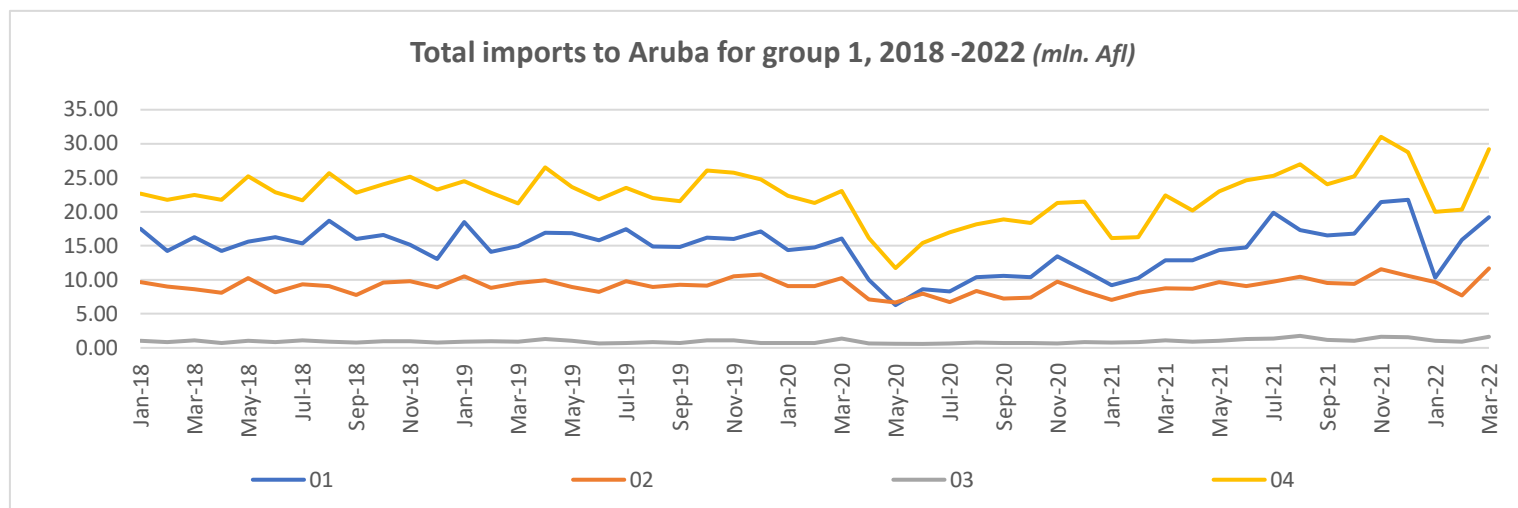

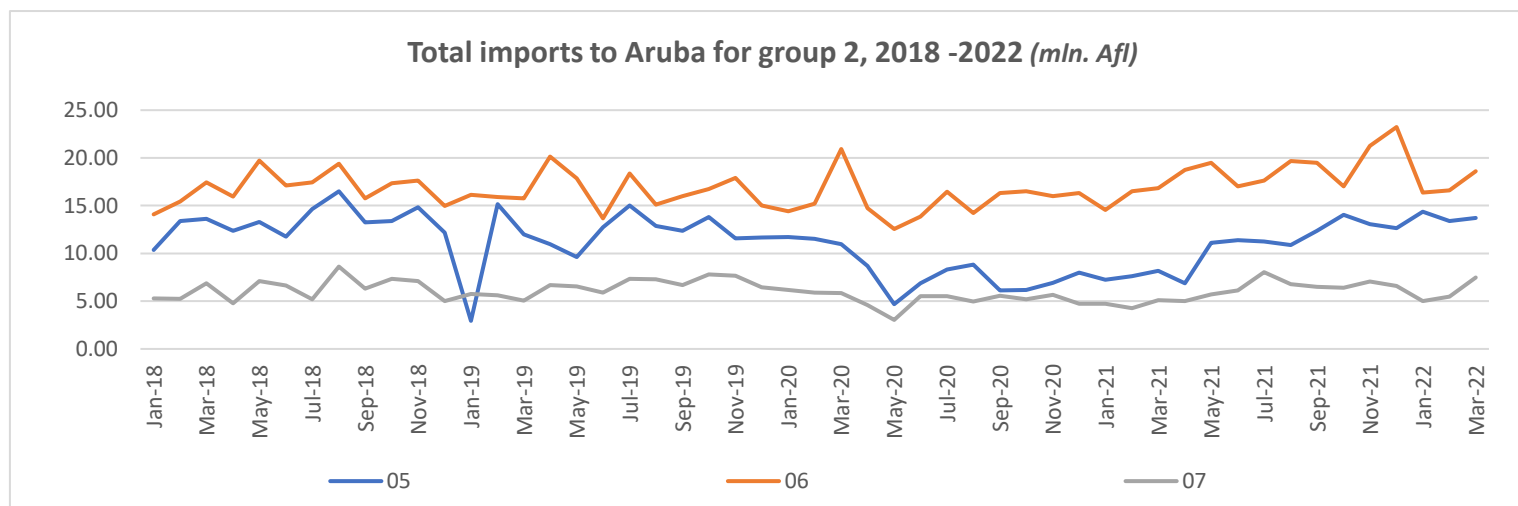

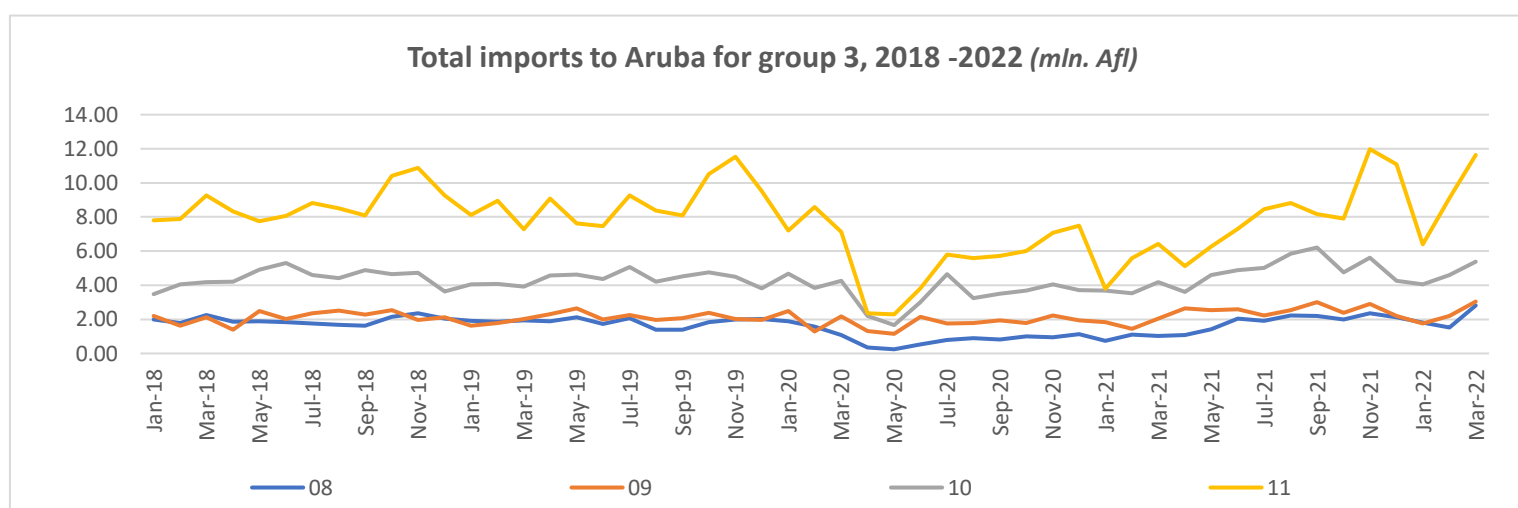
### TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

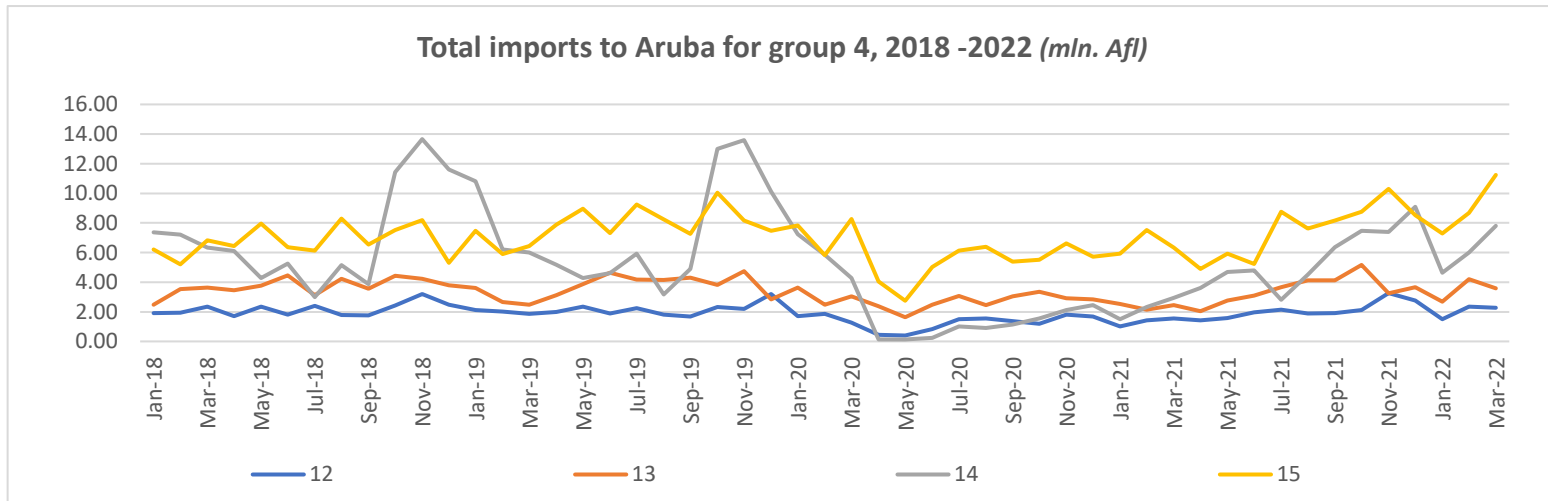

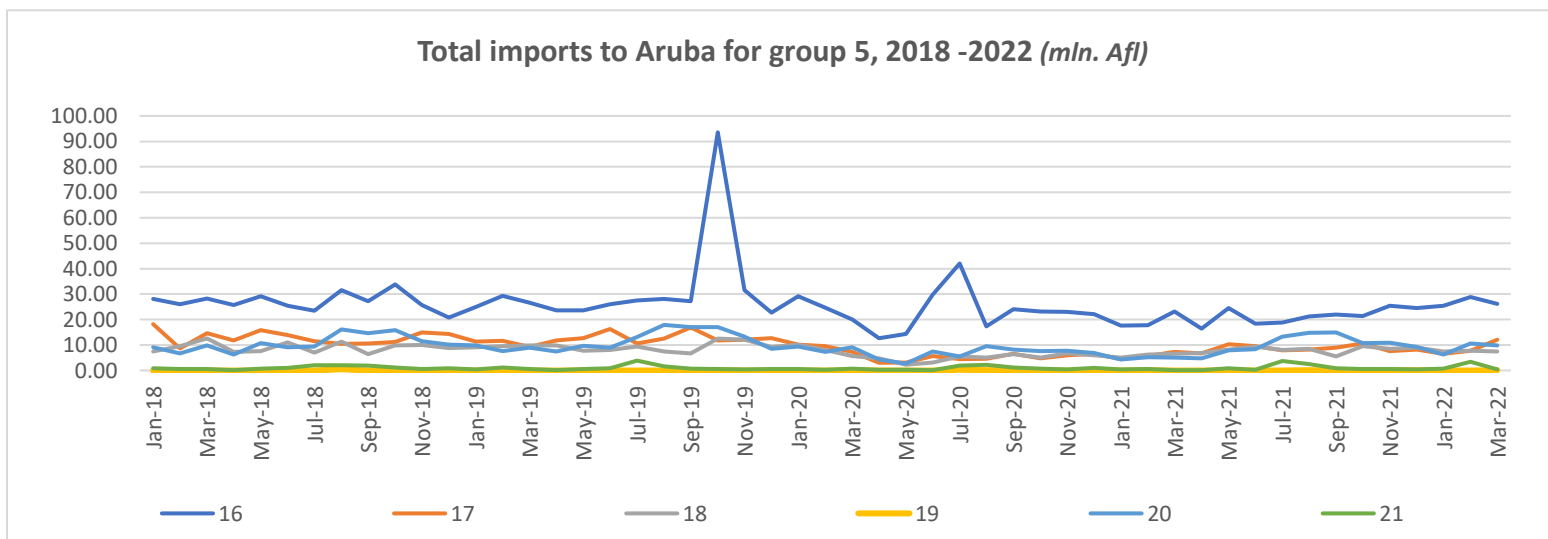

### TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022



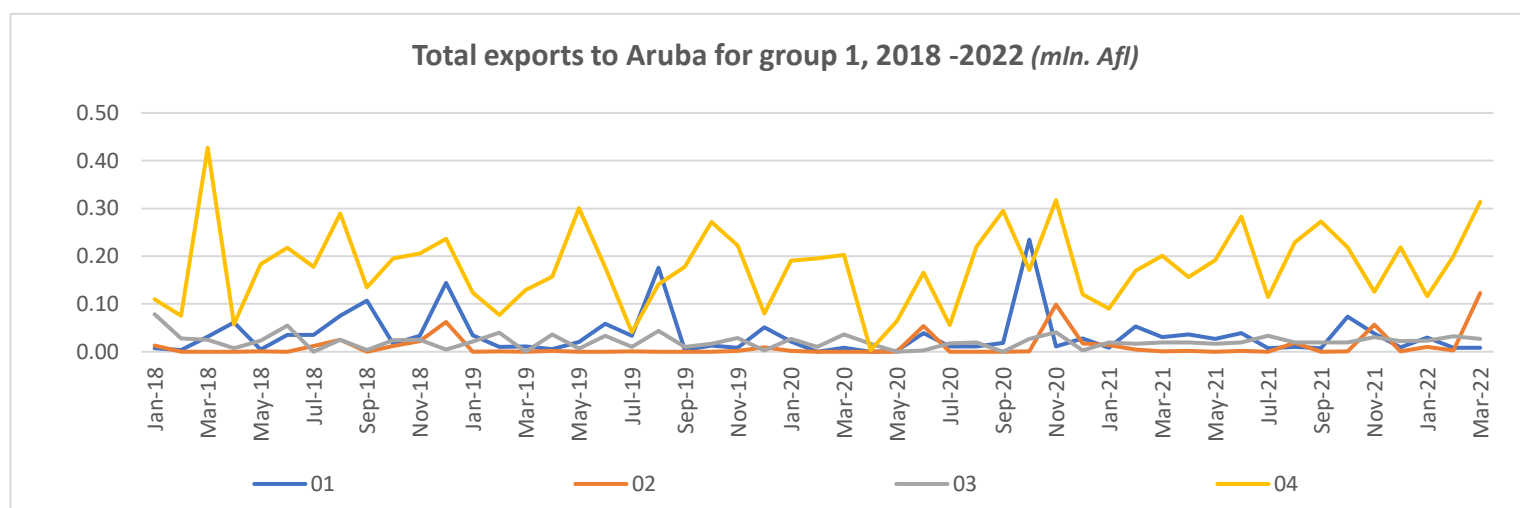

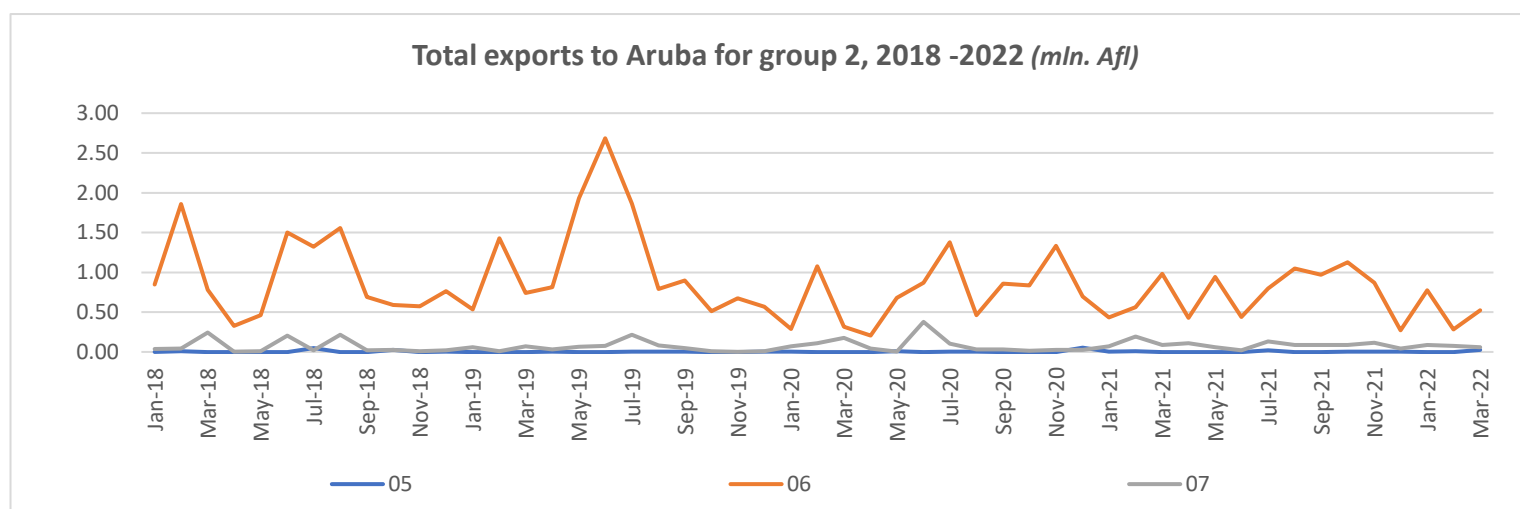

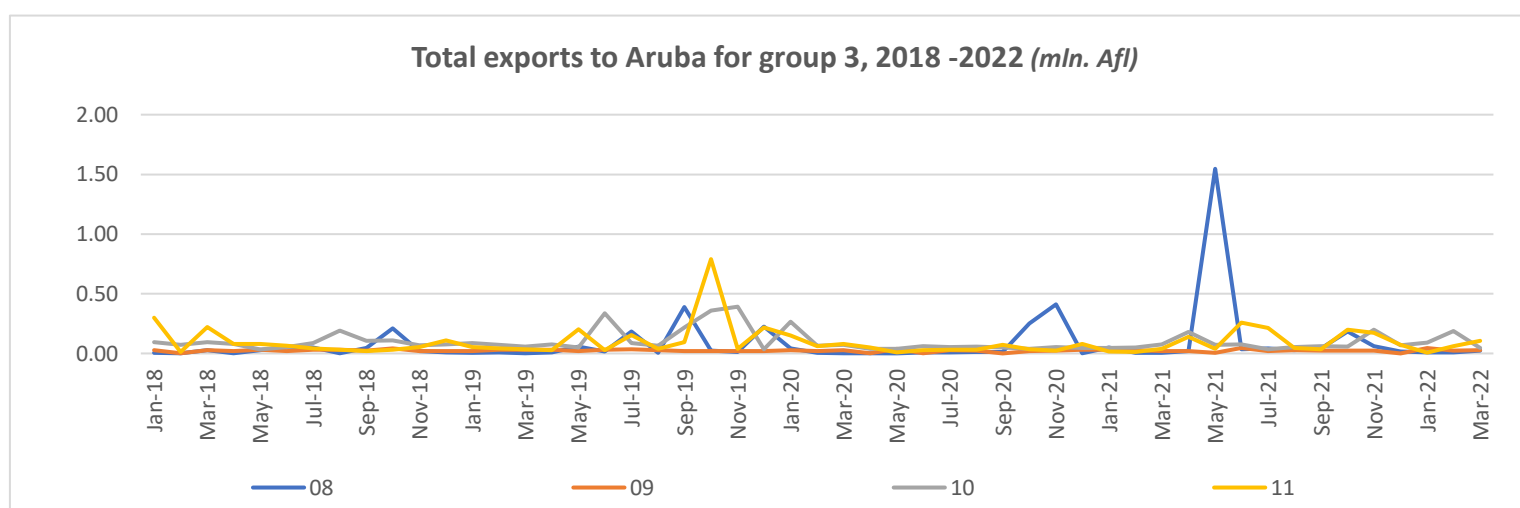
### TOTAL EXPORTS FROM THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

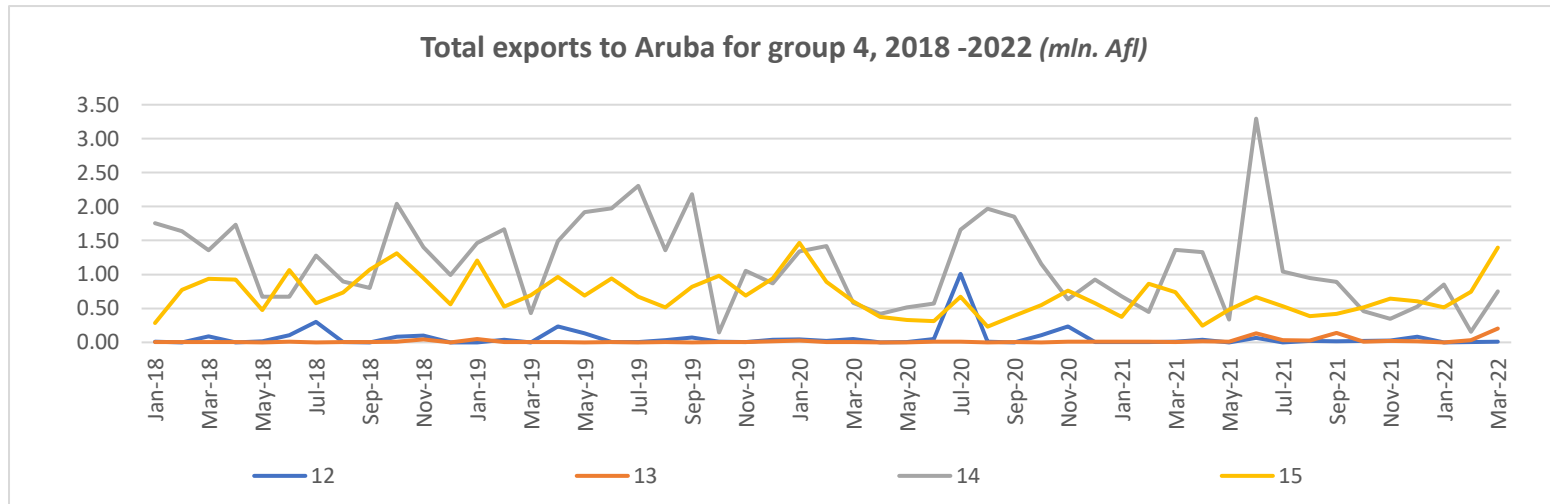

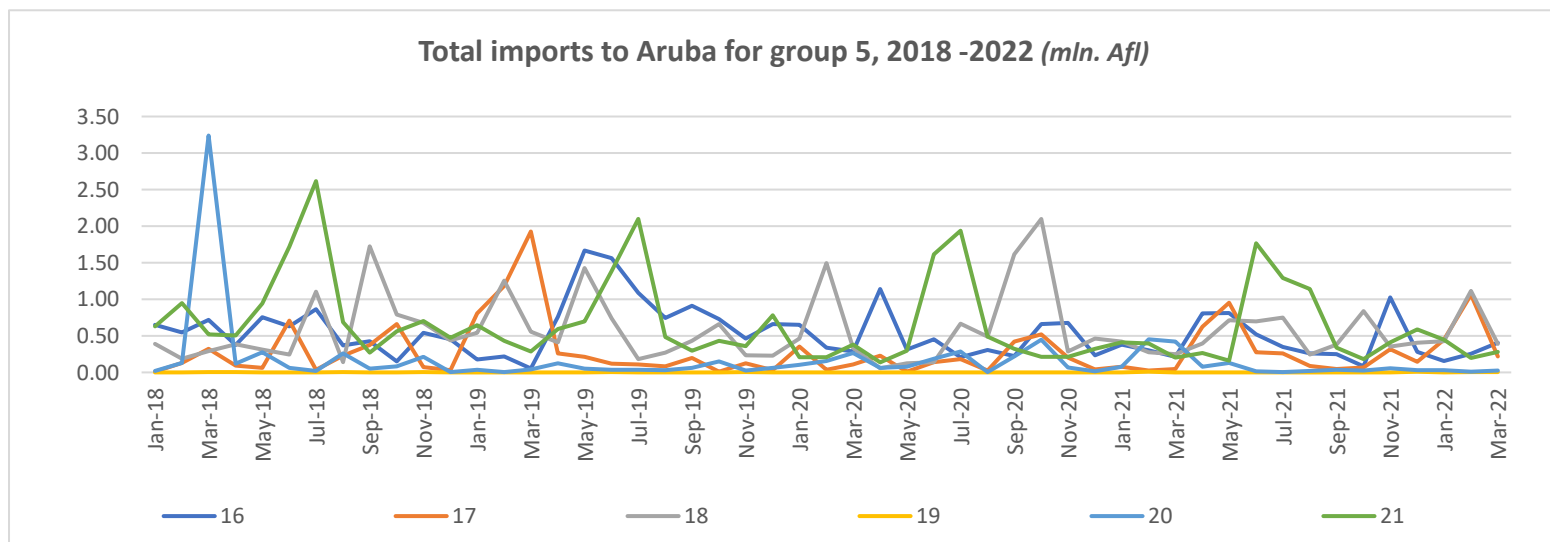
