

The Central Bureau of Statistics (CBS) is organizing an Economic Census from April to June 2023 to be able to provide the private and the public sector with reliable and actual data. Institutions that carry out an economic activity will be asked to provide, among others, data on their economic activity, their number of employees, and the total sum of wages and salaries paid to these employees. In addition, the institutions will be asked to report on their contribution to the tourism sector. The purpose of the Economic Census is threefold. A snapshot is obtained of all physical entities that are active on the island and a comparison with past similar exercises enables the CBS to determine the (long term) dynamics of entities. Furthermore, the data gathered helps the CBS to update its business register. Next to these goals, the Economic Census ultimately enables the CBS to report on economic data to international organizations (such as the World Bank and the United Nations) in accordance with the standards that are required internationally.

In relation to the Economic Census 2023 a total of 40 assigned interviewers will visit every entity where an economic activity is taking place. The interviewers will ask for a representative of the entity and will conduct the interview during their first visit or they will make an appointment with the representative to conduct the interview (preferably within a week's time). The representative is preferably the owner of the company or a person with sufficient knowledge of the operations and financials of the business. We kindly request to have the following information available to facilitate the interview:

Information needed for companies/foundations, including for each branch and supporting establishment:

- Main economic activity (and second and third economic activity if applicable)
- Products and services offered
- Products and services that are the main costs for the establishment to function

Information needed for each company/foundation (NOT for branches and supporting establishments):

- The registration number of this enterprise/foundation at the Chamber of Commerce (KVK) and at the Social Security Bank (SVB), and the "persoonsnummer"
- The exact year and month that this enterprise/foundation became active
- The number of persons working at this enterprise/foundation per April 1st, 2023 and the number of employees working at this enterprise/foundation registered at SVB and on the payroll per April 1st, 2023
- The number of proprietors and family workers, not on the payroll, working in this enterprise/foundation per April 1st, 2023
- The number of vacancies
- The amount of salaries paid for the month of March 2023
- The amount of salaries paid for the year 2022
- Total sales for the years 2020, 2021 y 2022
- Percentage of sales obtained via online sales (website or social media)
- Percentage of sales attributed to tourists
- Total amount spent on remodeling in the last 5 years

A copy of the complete questionnaire in four languages is available on the website of the CBS www.cbs.aw. The CBS will treat all gathered data with all the privacy required by law and will only publish statistics on an aggregated level.
