
CONSUMER PRICE INDEX

Inflation in September down by 0.2 percent

In September 2008, average prices in Aruba dropped by 0.2 compared to the previous month. Main price decreases took place in the sectors Transport & communication (-1.4%), Housing (-1.0%), Beverage & tobacco products (-0.4%) and Goods & services n.e.c. (-0.1%). On the other hand, prices in the sectors Clothing & footwear, Household operation, Food and Leisure & recreational goods increased by 2.0, 0.5, 0.4 and 0.02 percent respectively, compared to August 2008. On a year to date basis, prices in September 2008 rose by 0.6 percentage points compared to the same period of 2007.

On a yearly basis, consumer prices went up by 10.8 percent in September 2008. Major price increases were recorded in the following sectors:


- 1. <u>Housing:</u> Prices in this sector rose by 18.5 percent, mainly as a result of increases in "Water supply" (39.2%), "Domestic fuel and power" (31.0%), "Garden supplies (10.0%)", "Property maintenance goods" (6.0%) and "Property rent" (3.5%).
- 2. <u>Food</u>; Prices in the Food sector rose in September 2008 by 12.7 percent, mainly as a result of price increases of "dairy products" (21.7%), "fats & oils" (21.4%), "grain products" (17.2%), "potatoes, vegetables & fruit" (14.6%), "meat, poultry, game, fish & shellfish" (13.9%), "sugar, sugar products & chocolate" (8.2%), "groceries n.e.c." (7.9%) and "take away beverages & meal" (5.4%).
- 3. <u>Transport & communication</u>; With the exception of communication services (-0.3%), price increases were recorded for "Own transport" (16.2%), "Vehicle supplies" (14.0%) and "Public transport costs" (1.8%).

CONSUMER PRICE INDEX

Prices of water, electricity and gasoline


In September 2008, fuel surcharge dropped by 5.3 percent compared to the previous month, reaching Afl. 0.37. Average retail price of water (average usage of 22.4 m3) declined by 0.8 percent compared to August 2008. Gasoline prices in September 2008 dropped by 4.8 percent compared to the previous month, reaching the amount of Afl. 2.47 per liter. Furthermore, price of diesel dropped by 12.0 percent compared to August 2008, reaching an average price of Afl. 2.26 per liter.








CPI USA: seasonally unadjusted

UTILITIES

Water distribution down by 3.6 percent

In September 2008, average water distribution (houses, companies, hotels, government) dropped by 3.6 percent compared to September 2007, mainly as a result of a drop of 8.8 percent in the household consumption. On the other hand, usage increases has been recorded for hotels (6.9%), public sector (5.1%) and commercial sector (1.8%). On a year to date basis, total water distribution in September 2008 is running 0.1 percent above the level registered during the same period of 2007.


Electricity distribution up by 7.3 percent

In September 2008, electricity (in MWh) supplied to Elmar for distribution rose by 7.3 percent compared to September 2007. On a year to date basis, average electricity distribution in September 2008 increased by 1.4 percent, when compared to the similar period one year earlier.






GOVERNMENT REVENUES

Total tax revenue up by 13.2 percent

In September 2008, total tax revenue rose by 13.2 percent compared to September 2007. In the January to September period of 2008, total tax revenue increased by 13.4 percent compared to the similar period one year earlier. Profit tax revenue increased by 50.1 percent compared to the same period of 2007. In addition, wage tax rose by 10.3 percent compared to similar period one year earlier. On a year to date basis, taxes on commodities dropped by 1.9 percent compared to the same period of 2007, mainly as a result of decline in excises on gasoline, beer and tobacco products. The drop in the excises on gasoline is caused by the introduction of an absorption arrangement. The turnover tax brought up an additional Afl. 36.0 million, which is 38.8 percent higher compared to the comparable period of 2007.





TOURISM

Cruise visitor arrivals continued to fall since May 2008

Cruise passenger arrivals dropped by 22.9 percent in September 2008, when compared to September 2007. A total of 3 cruise vessels entered the port of Aruba during September 2008, down from 14 calls recorded in the same month one year earlier. In the January-to-September period of 2008, the number of cruise passengers rose by 21.4 percent compared to the similar period of 2007.


Hotel statistics for the month of September

In September 2008, room nights rented rose by 3.5 percent compared to September 2007. The occupancy rate in hotels was at 67.8 percent in September 2008, down from 71.4 percent recorded in September 2007. The average daily rate increased by 0.2 percent reaching Afl. 244.30. The revenue per available room and room revenue dropped by 9.5 and 1.3 percent respectively, compared to September 2007.




