

Foreign Trade, 1st Quarter 2017

The Central Bureau of Statistics presents the most important findings for the Foreign Trade of the 1st quarter 2017.

Total Import

The total import, in terms of weight, registered a decrease of 5.9% in the first quarter of 2017 (150.4 mln kg) compared to the same period in 2016 (159.7 mln kg), while, in terms of value, it increased by 9.9% from Afl. 460.4 mln to Afl. 506.0 mln.

Import to the free circulation area of Aruba* (weight)

Import to the free circulation area of Aruba, in terms of weight, registered a decrease of 6.2% in the first quarter of 2017 (148.8 mln kg) compared to the same period in 2016 (158.6 mln kg). During this period nine (9) of the twenty-one (21) sections, in terms of weight, registered decreases in import to the free circulation area of Aruba.

The largest decreases are observed for the sections "Mineral products" (-10.8 mln. kg), "Chemical products" (-0.4 mln. kg) and "Live animals and other animal products" (-0.3 mln. kg).

The largest increase is seen for the section "Food products" (0.6 mln. kg).

Import to the free circulation area of Aruba (value)

Import to the free circulation area of Aruba, in terms of value, registered an increase of 7.7% in the first quarter of 2017 (Afl. 483.0 mln) compared to the same period in 2016 (Afl. 448.4 mln). Eighteen (18) of the twenty-one (21) sections, in terms of value, registered increases in import to the free circulation area of Aruba.

The largest increase is seen for the section "Machinery & electrotechnical equipment (new & renewed)" (Afl. 8.4 mln). Furthermore, increases of Afl. 5.4 mln, Afl. 3.5 mln and Afl. 3.0 mln were registered for the "Food products", "Real pearls (natural) and other precious stones" and "Mineral products" sections, respectively.

The largest decreases are observed for the sections "Transport equipment" (Afl. -1.1 mln), "Optical instruments, apparatus and equipment" (Afl. -0.6 mln.) and "Arms and ammunition" (Afl. -0.1 mln).

The abovementioned Import (to the free calculation area of Aruba) is the result of Import by Sea and Import by Air, which had the following effects:

1. Import to the free circulation area of Aruba by Sea

Import by Sea to the free circulation area of Aruba, in terms of **weight**, registered a decrease of 6.3% in the first quarter of 2017 (148.0 mln kg) compared to the same period in 2016 (157.9 mln kg), while, in terms of **value**, it increased by 8.1% from Afl. 362.2 mln to Afl. 391.7 mln. The changes in the sections in this category (Import by Sea) represent for the greater part the changes in the total Import to the free circulation area of Aruba.

2. Import to the free circulation area of Aruba by Air

Import by Air to the free circulation area of Aruba, in terms of **weight**, increased by 7.5% from Afl. 0.68 mln in the first quarter of 2016 to Afl. 0.73 mln in the first quarter of 2017, while, in terms of **value**, it increased by 5.9% from Afl. 86.3 mln to Afl. 91.4 mln.

Import to the free circulation area of Aruba by Large companies**

Import by "Large companies", in terms of **weight**, increased by 0.8% from 24.0 mln kg in the first quarter of 2016 compared to 24.2 mln kg in the first quarter of 2017, while, in terms of **value**, it increased by 23.9% from Afl. 37.0 mln to Afl. 45.8 mln.

Total Export

The total export, in terms of **weight**, registered an increase of 63.8% in the first quarter of 2017 (6.1 mln kg) compared to the same period of 2016 (3.7 mln kg), while, in terms of **value**, it increased by 3.2% from Afl. 34.0 mln to Afl. 35.1 mln.

Export from the free circulation area of Aruba (weight)

Fifteen (15) of the twenty-one (21) sections, in terms of weight, registered increases in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Materials for the manufacture of paper, paperwork" (1.9 mln kg), "Base metals and derivated works" (0.3 mln kg) and "Vegetable products" (0.2 mln kg).

The largest decreases are seen for the sections "Works of stone, gypsum, cement, asbestos" (-0.3 mln. kg) and "Chemical products" (-0.1 mln. kg).

Export from the free circulation area of Aruba (value)

Fifteen (15) of the twenty-one (21) sections, in terms of value, registered increases in the export from the free circulation area of Aruba. The largest increases are observed for the sections "Real pearls (natural) and other precious stones" (Afl. 1.5 mln), "Art-objects and collectors items including toys" (Afl. 1.2 mln.) and "Optical instruments, apparatus and equipment" (Afl. 1.1 mln).

The largest decrease is seen for the section "Base metals and derivated works" (Afl. -0.5 mln). Furthermore, decreases of Afl. 0.4 mln and Afl. 0.2 mln were registered for the "Machinery and electrotechnical equipment (new & renewed)" and "Transport equipment" sections, respectively.

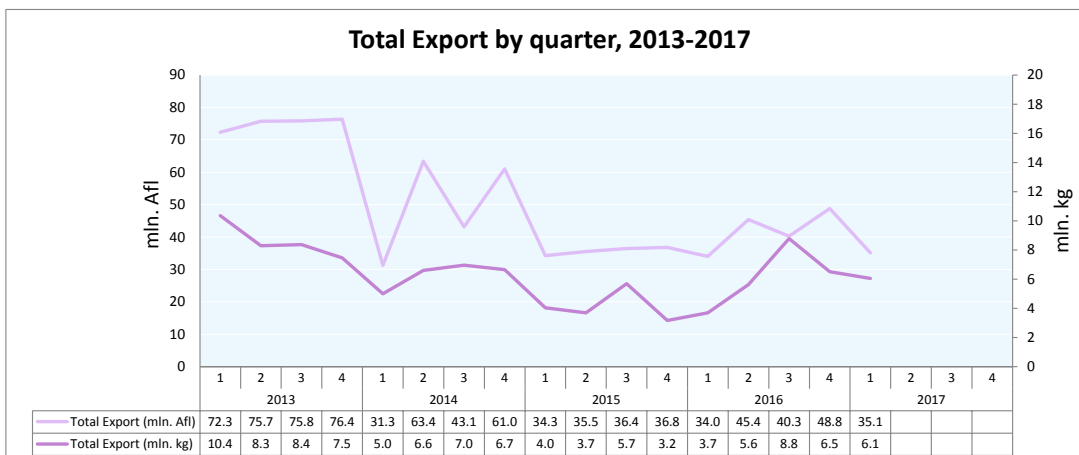
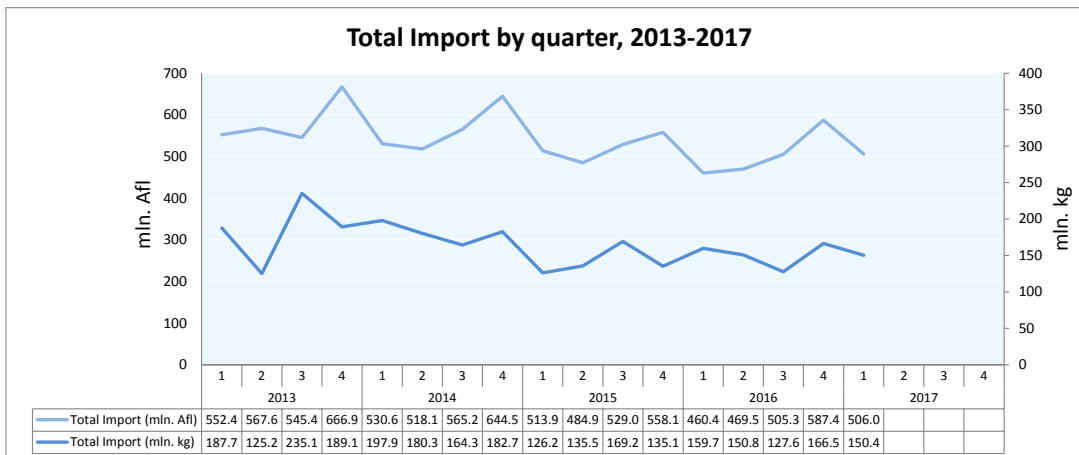
