The Central Bureau of Statistics hereby presents the most important preliminary findings regarding Foreign Trade for the month January of 2022. This review will focus only on the monetary value* of the imported and exported goods.

** The free circulation area of Aruba: The economic territory of Aruba, excluding the Free Zone.

The last 24 months change is calculated by comparing the average for the most recent 12-month period compared with the average of the preceding 12-month period.

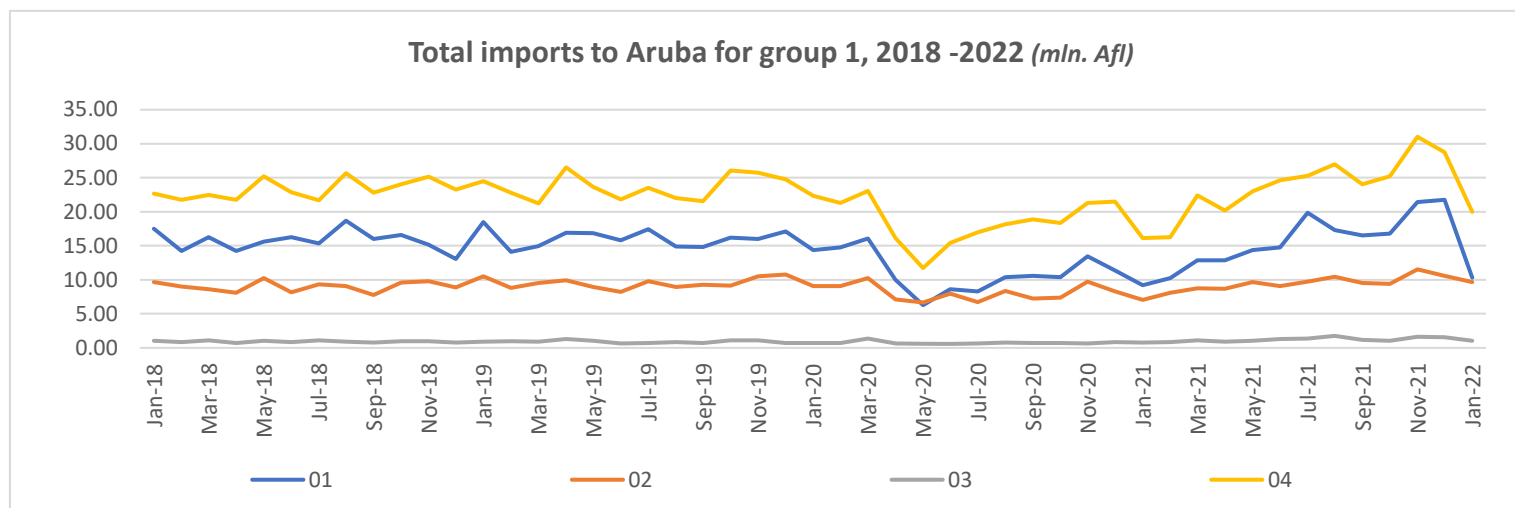

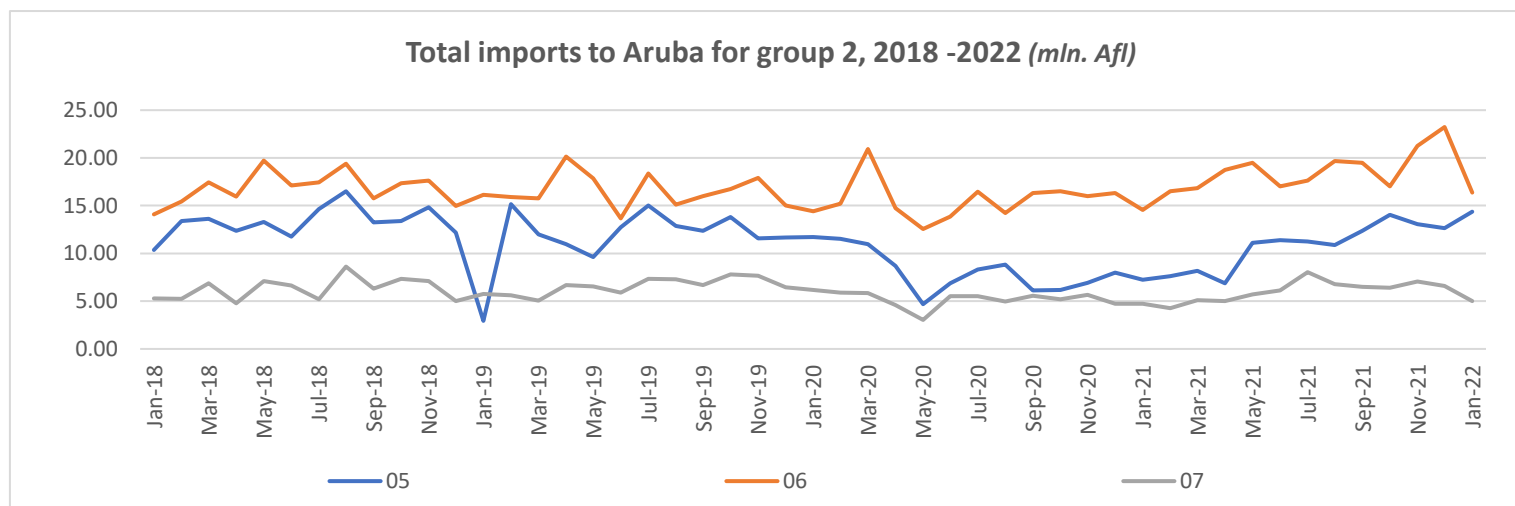

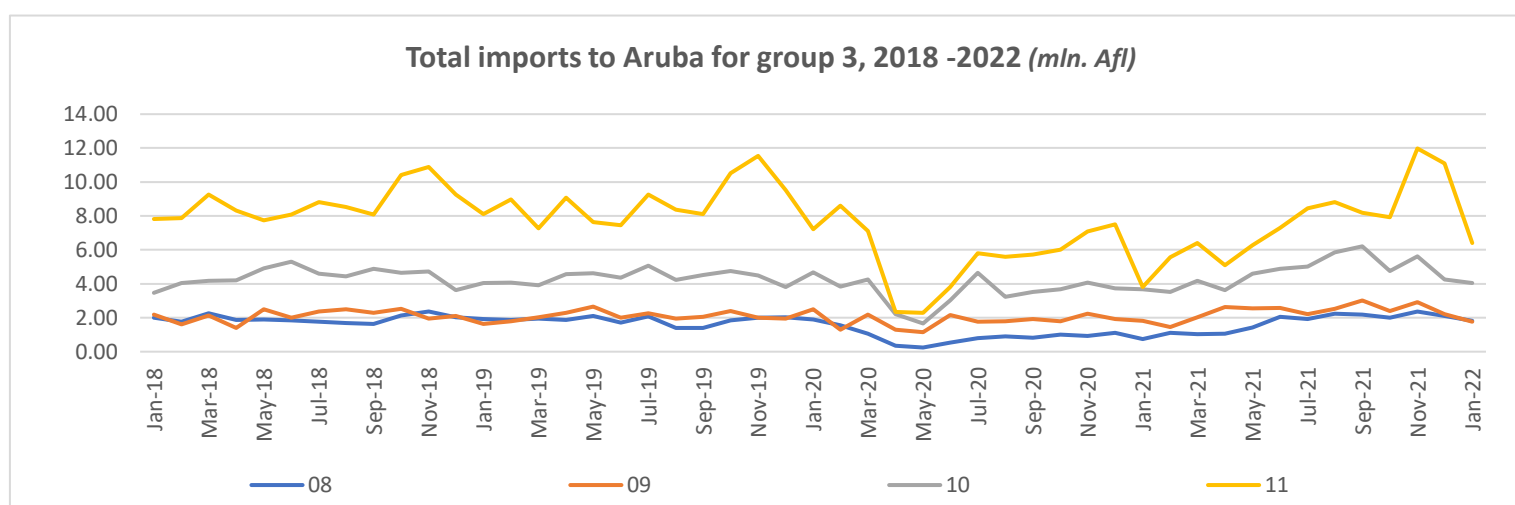
TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

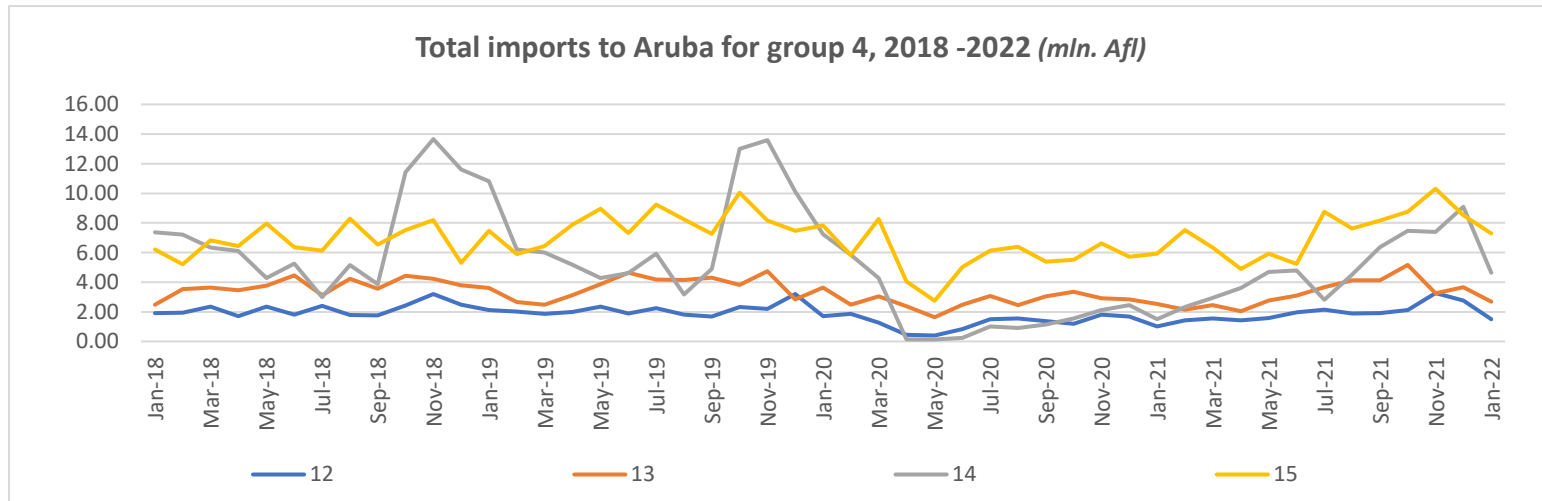

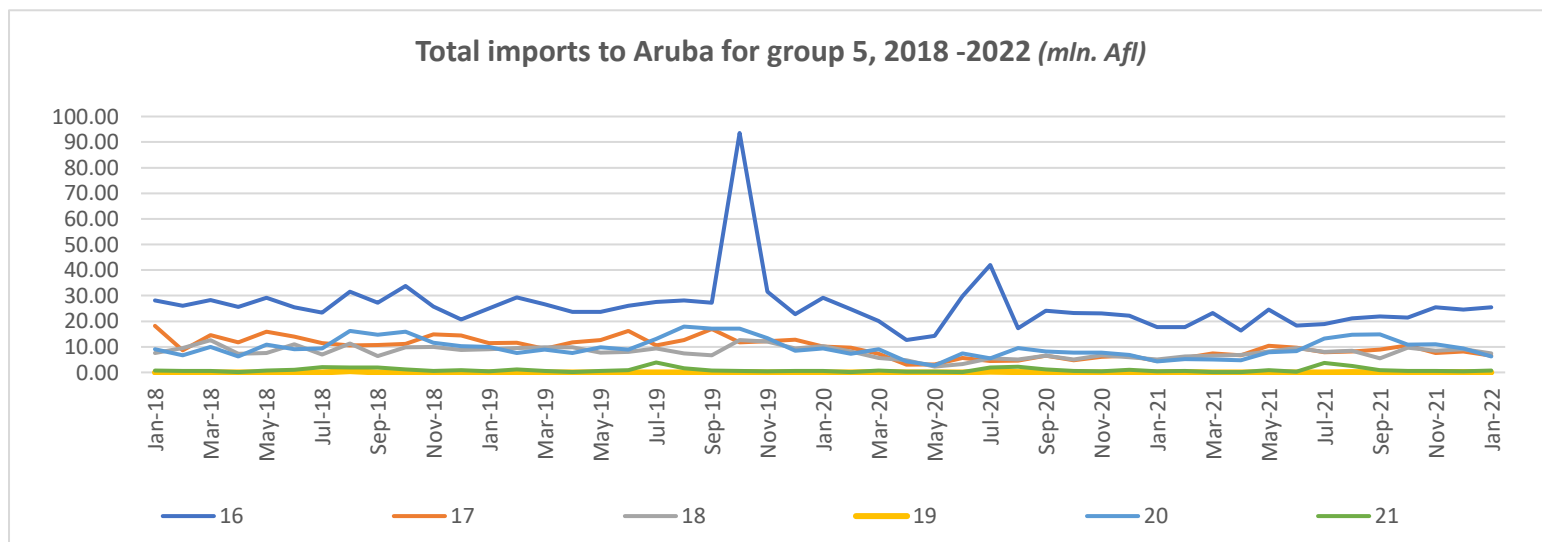

TOTAL IMPORTS TO THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022



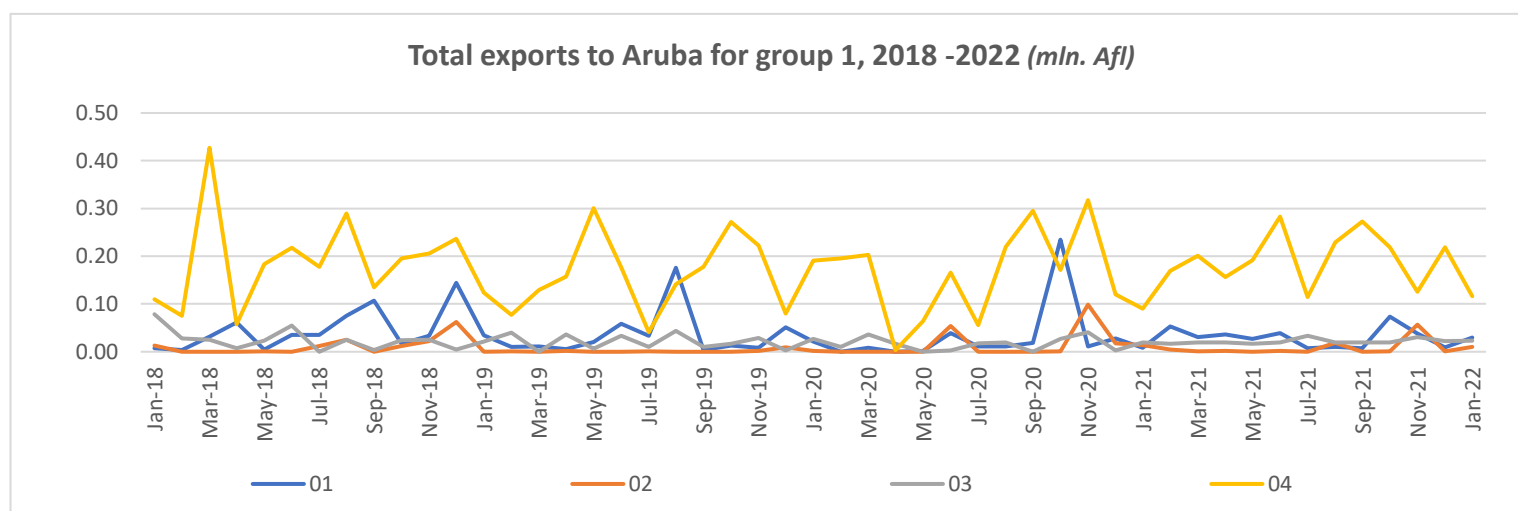

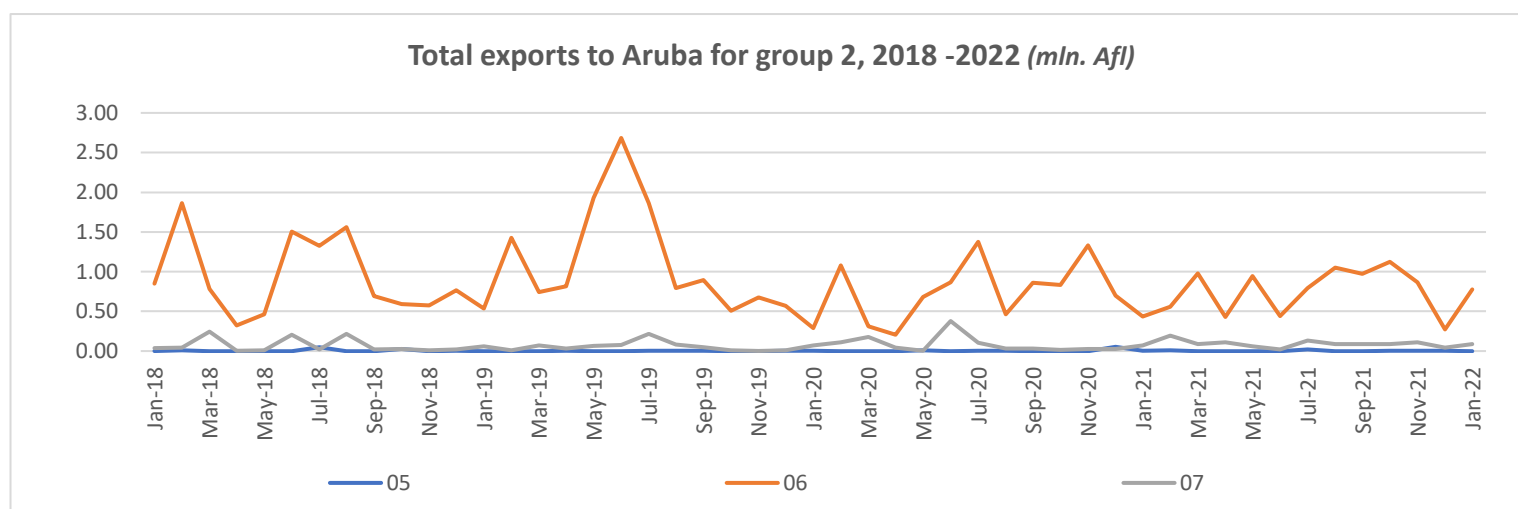

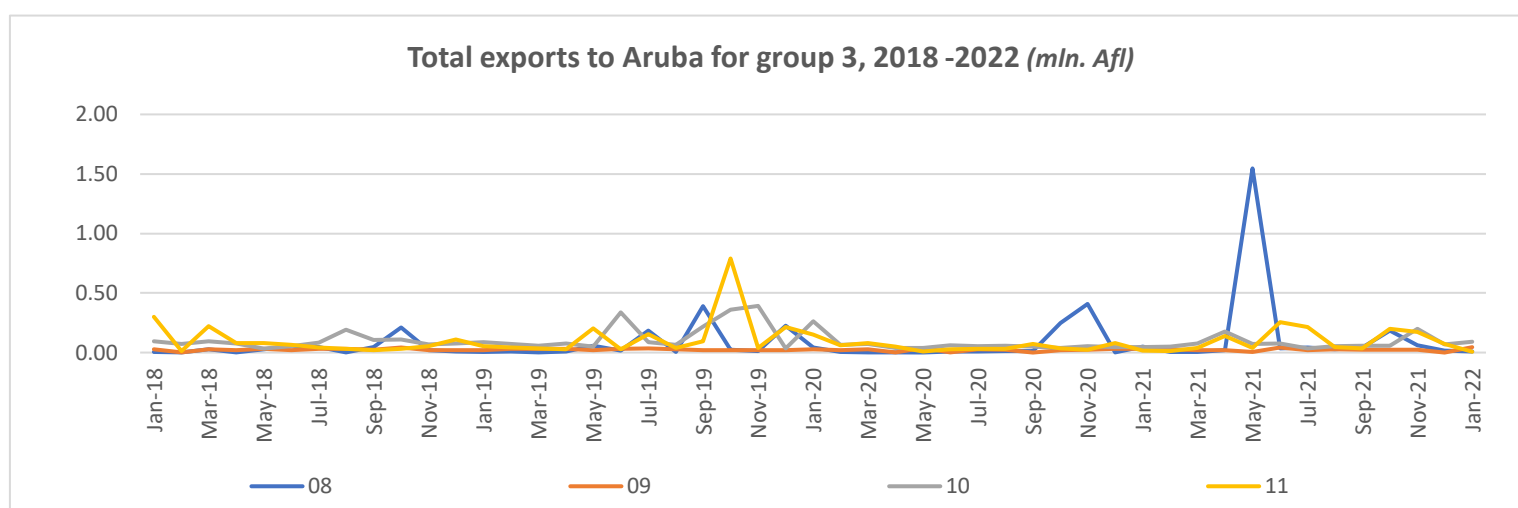
TOTAL EXPORTS FROM THE FREE CIRCULATION AREA OF ARUBA BY SECTION, 2018 - 2022

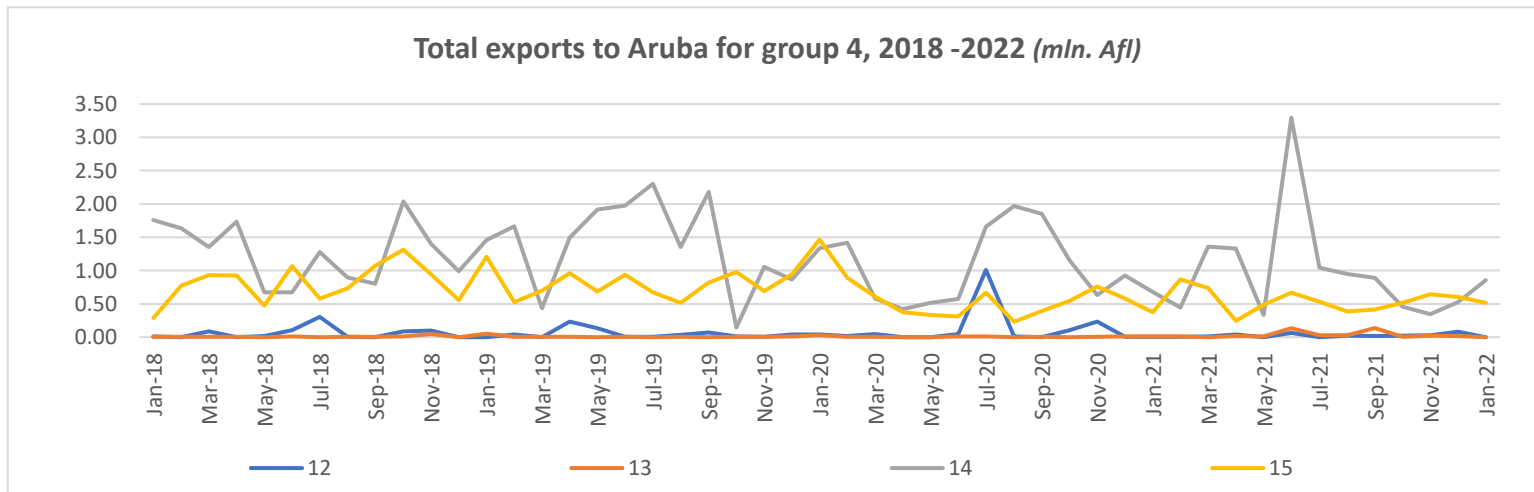

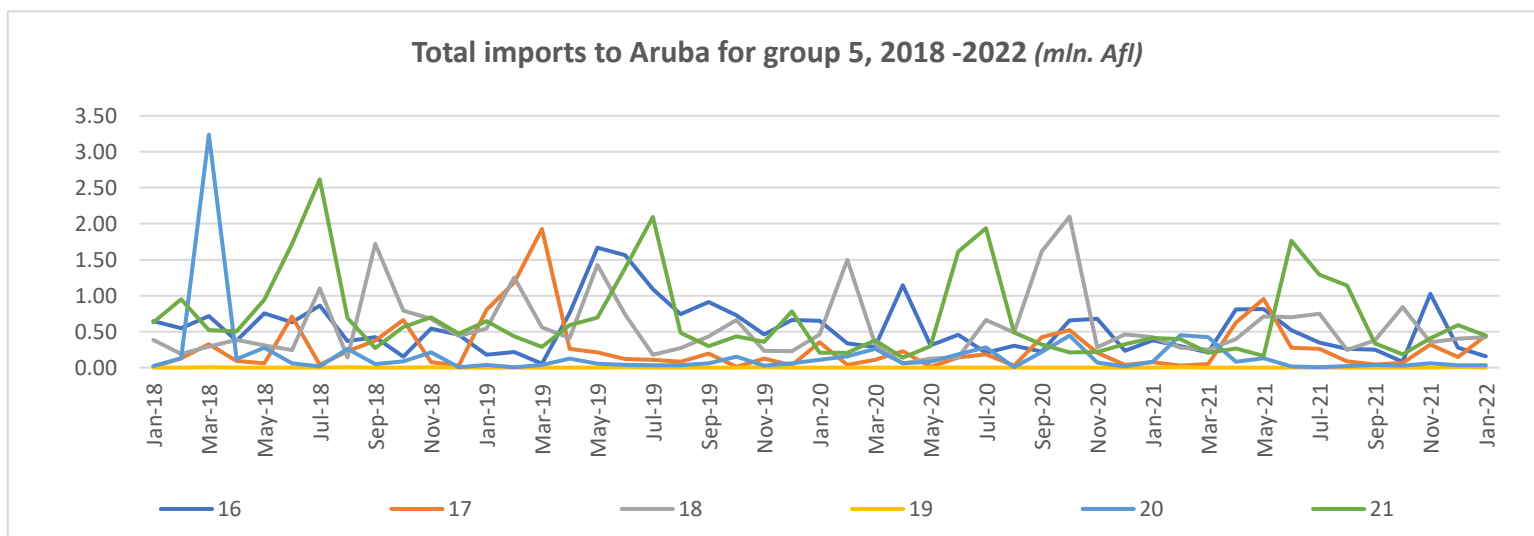
